


It delighted to know that the Pakistan Tanners Association is publishing its Annual Report for the year 2019-2020 containing inter-alia prominent activities of the Association.

Leather Industry is one of the pioneer sectors in the economy of Pakistan and enjoying 2nd export oriented industry status within the country after the Textile, which is playing a pivotal role in strengthening country's economy & exports and striving hard with all vigorous efforts specially keeping positive image of Pakistan world-wide by organizing Local & International Fairs & Exhibitions of Leather for the promotion & participation of its country wide members in a befitting manner.

While the beginning of 2020 has become quite difficult for the whole world and especially for Pakistan, because of the COVID-19 pandemic that badly affected the economy of Pakistan as well as this vital 95% export oriented Leather Industry which was in severe crisis due to COVID-19. International Markets for Finished Leather particularly America, Europe and Far East have closed their import operations, which were ultimately hurt the export activities of Pakistan with declining trend in exports for certain period.

Nevertheless, Pakistan fought the pandemic with resilience and zeal implementing the lock down in the very beginning of the crisis from March 2020 and adhered to SOP framed by Government with its letter & spirit with courage and dignity to defeat the virus impact.

With the blessing of Almighty Allah, now the business activities are restored with standard SOP and country-wide lock-down eased to maximum, the export of Pakistan is on right track showing steady growth to arrest the declining trend on priority with required pace of acceleration of exports ,which is comparably better than the other countries despite the fact that COVID-19 resulted in lockdown of all provinces of Pakistan for about 4-5 months.

Despite the COVID-19 crisis, Pakistani Leather is recognized classic in quality worldwide and Pakistan's Leather Industry is also commemorated as one of the World Class Leather Industries. Our potential member manufacturers & exporters, despite several hurdles, are making all out endeavor towards value addition immaculately to attract the end users aboard. However, with the changing pattern, fashion and designs of leather and leather products globally we acutely need to adopt latest technology and skill development with adoption of more scientific techniques in producing innovative leather articles for which we desperately need support from the Government, which is inevitable to be competitive in the international market for the desired goals. We rest assure with firm confidence to increase the exports which could be around 40% to 50% in the upcoming financial year(s), if the following real bottlenecks with essential tools for facilitation with effective level playing field in comparison with neighbor competitors like India, Bangladesh & China are addressed, removed & offered by the Government:

- Inclusion of Dyed/Finished Leather in the DLTL Scheme 2018-2021 with retrospective effect without incremental obligation.
- Removal of irrational duties/taxes such as ACD, AGST on import of remaining basic tanning Chemicals, Machinery & raw material for leather industry, which would enable to reduce the product cost which is already exorbitant in comparison with neighbor competitors.
- Issuance of revised SRO 578(I)/2016 dated 1st July'2016 for the import of 24-Tanning Machineries with 50% grant upto Limit of Rs. 10 Million to produce best quality leather for fashion articles as demanded by foreign buyers and famous brands.
- To allow 75% Matching grant for setting-up of Effluent Treatment Plants in individual tanneries.
- To allow Government subsidy on Int'l Lab testing for Leather.
- Allocation of Pak Rs.300 Million required for Air Freight subsidy on exorbitant charges during covid-19 effective from March'2020 to Nov'2020.
- To allocate Pak Rs.133 Million for the Government subsidy for participation in Int'l Leather Fairs thru EDF for which comprehensive proposal has been submitted to EDF/MOC.

I heartily wish leather industry would progress rapidly with steady growth in future with the required incentives.



It is certainly an honour and privilege having been bestowed upon me by being elected unanimously as Chairman of Pakistan Tanners Association (Central) for the year 2019-2020 first time and confidence of PTA members reposed in me to lead the Association in the best interest of PTA members and Leather Industry as awell.

As Chairman, Pakistan Tanners Association, I take the opportunity of presenting the Annual Report containing the salient activities and performance of the outgoing Central Executive Committee on the conclusion of my term of Chairmanship for the year 2019-2020 in pursuance of Article 40(b)(ii) of the Memorandum and Articles of Association of Pakistan Tanners Association duly approved by the Government of Pakistan, Ministry of Commerce through the Directorate General of Trade Organizations under TOR, 2013 and by the Securities Exchange Commission of Pakistan (SECP).

At the very outset I would like to acknowledge the support and cooperation which I received from the entire Central Executive Committee and in particular Senior Vice Chairman, Mr. Fazalur Rehman Sheikh and Vice Chairman, Mr. Muhammad Shafi for their valuable advices and timely support despite difficult time experienced during COVID-19 pandemic and its impact on our industry consisting 9-months from March-November 2020. As a result, our members facing the COVID-19 Crisis and subsequently lockdown hit the export of Leather Industry worsen.

I would like to thank and acknowledge the support of all my colleagues Mr. Anjum Zafar, Mr.Amjad Hafeez, Mr.Kamran Habib, Kh. Muhammad Mehr Ali,Mr. Azam Malik, Mr.Danish Naseem, Mr. Naeem Akhtar, Mr. Tanveer Aslam Chawla, Mr.Muhammad Shahid, Mr.Naveed Ahmed, Mr.Tahir Mushtaq, Sheikh Muhammad Shafi and Mr. Muttaher Shafique Pasari, Members Central Executive Committee for the year 2019-2020 for their participation in the CEC meetings and for taking interest in resolving PTA's issues more enthusiastically and their cooperation for the betterment of leather industry highly appreciated.

I would also like to thank Mr. Muhammad Musaddiq for his remarkable efforts for organizing 6th Pakistan Mega Leather Show-2020 consecutively at Lahore in January'2020 successfully, I appreciate the good gesture and support of Mr. Agha Saiddain in taking the affairs of the Association, participating in various high-level meetings at Islamabad and his cooperation in organizing PMLS-2020 from its inception, Mr. Amanullah Aftab for holding International Fairs in befitting manners as well as facilitating members' participation in the approved Int'l Leather Fairs & Exhibitions organized in different countries and actively tackling issues with TDAP especially for releasing subsidy in favour of PTA member participants in various international fairs as allocated by TDAP to PTA

I heartily thank all other members who despite being non-CEC members Mr.Mansoor Iqbal, Mr.Gulzar Firoz, Mr.Hamid Arshad Zahur, Mr.Khurshid Alam, Mr. Shahid Usman, Mr. Ejaz Ahmed Sheikh, Mr. Aziz Ahmed, Sh. Saqib Saeed Masood, Mr. Rehan Sheikh Hannan, Mr. Abdul Salam, Mr. Badre Alam, Mr. Nasir Anwar, Mr.Muhammad Naim Shaikh, Mr. Muhammad Tayyab and Mr. Muhammad Zaheer for extending their full cooperation by favouring the Association with their genuine visions, valued suggestions and time devotion to resolve different issues/problems pertaining to the leather industry.

During my tenure I and my colleagues took-up various core issues with the Ministry of Commerce, FBR at Islamabad and TDAP at Karachi and persistently followed-up each issue. I thankful Mr. Anjum Zafar and Mr. Agha Saiddain who supported me at every forum and spared their precious time for participating in Various meetings and in particular visits to Islamabad accompanied with me in the best interest of the member exporters to resolve leather industry's issues.

I also acknowledge and appreciate the members who participated in the CEC meetings as well as at high-level meetings on my request held with the President of Pakistan, Ministry of Commerce and FBR at Islamabad and various Government Officials at Lahore and Karachi. They spared their precious time with their valuable views and suggestions to boost export of leather industry and toiled to draw government attention towards numerous issues & impediments of the value added export oriented industry of the country.

#### My Vision

From my first day of assuming charge of the Association on 1st October'2019, I studied all the important existing and pending issues of the Leather Industry left during the end of the tenure of my immediate predecessor, Mr. Agha Saiddain which helped me a lot to find out a clear cut strategy how to tackle our members' genuine problems at all Government fora for redressal drastically and for further development of dwindling Leather Industry.

First, I streamlined all the issues being faced by the tanning industry and sent comprehensive presentations to President of Pakistan, Prime Minister of Pakistan, Chief of Army Staff, Ministry of Commerce, Federal Board of Revenue, Trade Development Authority of Pakistan, IOCO and SBP for their pragmatic favourable consideration for the up-lift of leather Industry. Inviting immediate attention for resolution of 2nd Biggest export oriented Leather Industry facing severe crisis, to enable this productive industry to play its pivotal role for promotion of exports to yield more sizeable foreign exchange for the country.

I also invited attention of the Government towards the continuous declining trend in export of Leather sector as well as by describing detail reasons at various for afor the downfall in Leather Exports alongwith suggestions for remedies.

I took-up the following core issues on top priority with the concerned government authorities i.e.:-

#### **CORE ISSUES OF LEATHER INDUSTRY**

- 1. Reinstate the Zero Rated Status for Leather Sector of Pakistanas earlier allowed to 5-export oriented sectors with immediate effect along with the restoration of SRO # 1125, which was revoked earlier by the Government OTHERWISE to consider the reduction of Sales Tax from 17% to 5% atleast for Leather Sector of Pakistan, which is 95% export oriented sector of the country.
- 2. To include "Dyed/Finished Leather" having H.S. codes # 4107.1200 / 4107.9200 / 4107.9100 / 4112.000 / 4113.9000 & 4113.1000in the new DLTL Scheme notified vide SRO # 711(I)/2018 dated 08.06.2018.
- To issue revised SRO # 578(I)/2016 dated 01.07.2016by notifying for import of 24-Tanning Machineswith due Government subsidy.
- 4. To declare Hides & Skins as "Agricultural Produce" for exemption from levy of Withholding Tax.
- 5. To allow Duty Free Import of Basic Raw Materials i) Raw Hides & Skins ii) Tanning Chemicals iii) Tanning Machines.
- 6. To remove 2% ACD on basic raw material i.e. Wetblue of Cow & Buffalo imposed through SRO 670(I)/2019 dated 28.06.2019.
- 7. To remove ACD charging from 2-7% on tanning chemicals and tanning machines which ultimately increased the cost of products which rendering our member exporter in-competitive in International market as compared to neighbor competitors countries.
- 8. To remove 4% Customs Duty on Import of Tanning Machinery.
- 9. To remove 10% Sales Tax on import of Tanning Machinery OR allow Indemnity Bond of 17% instead of 7% to save our members from cash flow problem.
- 10. To ensure to incorporate the following H.S. Codes # 4107.1200 / 4107.9200 / 4107.9100 / 4112.000 / 4113.9000 & 4113.1000of Finished Leather in the list of 313 approved items in the2ndPhase of Pak-China FTA at Zero Rated Import from Pakistan into China as already approved by MOC.
- 11. To allow complete withdrawal of Additional Regulatory Duty imposed on import of various basic tanning chemicals vide SRO # 1035(I)/2017 dated 16th October'2017, as the recently issued SRO # 06(I)/2018 dated 03.01.2018 is still imposed at 10%, which needs to be removed on basic tanning Chemicals for Tanning Industry.
- 12. To allocate already approved 80% fund/subsidy for organizing of 10 International Fairs as was approved by the Advisor to Prime Minister on Commerce during a meeting held on 18.09.2019.
- 13. Removal of irrational condition of TDAP for 2-times and 5-years participation of PTA's member exporters in International Fairs from their prescribed Rules & Regulations for International Fairs.

#### **CORE ISSUES OF LEATHER INDUSTRY**

- To implement rates of duty drawback on export of finished leather asoriginally agreedwith IOCO w.e.f. The date of application i.e. 17th May'2012 instead of unilaterally slashing down the rates of DDB for Leather by FBR notified through FBR's SRO 923(I)/2015 dated 8th September'2015.
- 15. To release sales tax refund /income tax refund /Duty Drawback Claims, restoration of sales tax registration and other issues.
- To allow an extension for the reduced rate of Power Tariff for Electricity @7.5 cent/Kwh and Gas @US\$6.5/MMBTU to Five Zero Rated Industry including Leather.

#### Export Performance

I would like to share that the 95% export oriented industry of the country is in severe crisis of COVID-19 outbreaks from mid March 2020 till now, which is, of course, a universal phenomenon and brought severe effects to the leather industry this year in addition to the burning issues as already faced by the exporters of this historical industry.

During the Covid-19 pandemic around 50% to 70%, export orders had been cancelled while the due payments of shipments that were already exported are pending by the Customers and future orders expectation and discussion on finalizing of the business deals have also been jeopardized for cancellation and freight of the shipment has been increased from 3 to 4 times and foreign customers are not willing to share with our member exporters and they are persistently asking for a reduction in price to be around 10 - 20% which is well nigh impossible owing to the increase in the cost of production and Corona Virus outbreaks in the various areas of the country.

Although Covid-19 resulted in a complete lockdown of all Provinces of Pakistan since three months consecutively, the exports performance of Pakistan's Leather Industry which is comparably better than the other countries and stood at US\$ 765.264 Million during the current financial year July-June 2019-2020 showing slight decreased by 9% as compared to the same period of last year.

Despite the discouraging trend in export our potential and genuine member exporters would have played more viable and result oriented role if the Government meted out business friendly treatment with a pragmatic approach to resolve leather industry's issues on priority. The following need Government's urgent attention for accelerating export growth:

- Re-inclusion of Dyed/Finished Leather in the new DLTL Scheme for the year 2018-21 with all related HS Code of Leather.
- To allocate a fund of Pak Rs.300 Million (Approx.) being Air Freight Subsidy@75% of the air freight affected from COVID-19 Pandemic from March-2020 and further expected till December'2020.
- Relaxation of Duty Structure on REMAINING 6 basic Tanning Chemicals for Leather Industry out of total 8 shortlisted already submitted to MOC earlier. It was firmly assured by Advisor to PM numerously orally for ensure inclusion of all 8 H.S. codes, but unfortunately 6 H.S. codes are not entertained out of 8 shortlisted.

- Request for removal of 3% AGST & increased percentage of Income Tax from 2% to 5.5% imposed on Commercial Importers for Leather Industry, who are allied suppliers of the Industry to cater to the needs of the Industry for value addition, resultantly the exporters would be affected severely with increase of production cost, which is already on higher side in comparison with regional competitors.
- Continuation of Regionally Competitive Energy Tariff; 7.5 Cents/Kwh Power, \$6.5/MMBTU for Five Export Oriented Sectors including LEATHER.
- Release of Sales Tax, Income Tax and Duty Drawback Claims to Leather Sector's Exporters.
- Removal of collection of EDS @0.25% on export proceeds for atleast for 3 years.
- Removal of further collection of 1% Withholding Tax on export proceeds at least for 3 years.

#### Role Of TDAP

I would like to appreciate the support and cooperation of TDAP despite hard time being faced by all up-country exporters due to Corona Virus Crisis in mid March-2020. TDAP persistently organized meetings with PTA Delegation for resolution of Leather Industry issues during COVID-19 Pandemic and considered how to explore country's export. Following core issues were taken-up with TDAP for immediate remedial action:

- Request for recommendation to Ministry of Commerce for granting subsidy on Higher Freight Charges for Leather Shipments during COVID-19 for facilitation of PTA member exporters.
- Request for allocation of following 4 (four) shortlisted list Int'l Fairs out of 7 (Seven) Fairs with increased subsidy percentage @ 75% irrespective of 5 years & 2 times participation condition to PTA interested member participants, which is completely irrational & detrimental under the prevailing circumstances of COVID-19:
  - 1. Leathertech 26-28th Nov. 2020 Nov Dhaka.
  - 2. Lineapelle, Feb 2021, Milan, Italy.
  - 3. APLF March 2021 HongKong.
  - 4. Shoes & Leather, May-June'2021 at Guangzhou, China.

Due to COVID-19 outbreaks all over the world, PTA organized only three following International Fairs @40% subsidy on space and construction for organizing Pakistan Pavilion for its interested member participants in my tenure from October'2019.

- Lineapelle Fair 2-4th October'2019 in Milan, Italy.
- LeatherTech 31st October-2nd November'2019 at Dhaka, Bangladesh.
- Lineapelle Fair, 19-21st Feb. 2020 at Milan, Italy.

Luckily subsidy of both the above Fairs was already released by the TDAP and PTA's member participants concerned have got their due subsidy

#### EDF – Ministry of Commerce

I would like to apprise you that Pakistan Mega Leather Show which is consequently organizing since last six years in Lahore Int'l Expo Centre successfully wherein Local and international companies will display machinery, components, chemicals and accessories for leather, leather garments, footwear and leather-goods. The show is organizing for the promotion of the leather industry of Pakistan in general and to accentuate the image of Pakistan internationally in particular.

I appreciated the EDF for releasing fund through TDAP for organizing of 5th PMLS-2019 amount to Rs.10,496,000/- (Rs.5,248,000 to each Association – PFMA & PTA) while the pending subsidies for 4th PMLS-2018 & 6th PMLS-2020 under finalization process by EDF & TDAP and hope to be released soon.

I also approached EDF & TDAP for granting 75% Air Freight Subsidy on Export Shipments of Leather amount to Rs.300 Million affected due to COVID-19.

#### SBP - State Bank Of Pakistan

Just from my assuming charge as Chairman, PTA, I taken-up the following matter with SBP:

- To extend deadline for submission of claims with incremental export from 31st October'2019.
- To allow member exporters for Non-incremental claims for DLTL (as already been expired) to allow for acceptance as special case.
- To reduce Mark-up rate to 5%.

  The SBP has curtailed the end user mark-up rates on Temporary Economic Refinance Facility (TERF) to 5% from the existing 7% and on LONG TERM FINANCING FACILITY (LTFF) from Non-Textile Sector to 5% from 6%.

#### TASK FORCE - MoC

Ministry of Commerce in its efforts to promote import substitutions and boost export of Pakistan, had assembled a TASK FORCE named "Make in Pakistan", the Task Force met with industries/associations with greatest export potential to explore areas of cooperation and support. By using this forum, PTA submitted its well formulated proposals especially shortlisted 8-Tanning Chemicals using in manufacturing of Finished Leather demanding for reduction in Custom Duty & ACD. I have sent following proposals to the Chairman, Task Force for recommendation for inclusion in the Federal Budget 2020-2021:

1.	To include "Dyed / Finished Leather" with the following H.S codes in the new DLTL Scheme announced vide SRO # 711(I)/2018 dated 08.06.2018 for which it was ensured categorically by MOC to PTA for the inclusion but not yet implemented: - H.S. Codes # 4107.1200 / 4107.9200 / 4107.9100 / 4112.000 / 4113.9000 & 4113.1000.
2.	It is recommended to abolish ACD and also rationalization of CD on basic chemicals which are only used in tanning industry for finished leather production to reduce cost of production which has become too high in comparison with the neighbor competing countries to provide level playing to this industry to compete in international market effectively.
3.	To rectify the anomaly of Removal of 2% ACD on basic Raw Materials i.e. Wet Blue of Cow & Buffalo as now imposed thru SRO # 670(I)/2019 dated 28.06.2019 for the Leather Industry while rest of raw materials i.e. wet blue of sheep & goat skins has already been allowed in the said SRO, which needs to be rectified as already assured by MOC during meeting.
4.	Government has <b>removed 4% customs duty</b> on import of tanning machinery <b>but still 10% on sales tax is charged</b> on import of tanning machinery added with indemnity <b>bond of 7%</b> requested to remove 10% sales tax on import of tanning machinery. This will help us to import latest technology to upgrade our industry. However, if removal of 10% sales tax is not possible in such case PTA suggested for <b>indemnity bond for whole 17%</b> to save us from cash flow problem.

#### Achievements

It is my pleasure to share that due to my persistent approach, active follow-up and collective efforts of my team of Central Executive Committee as well as PTA Central Secretariat, we have achieved following important incentives out of our above mentioned 16-Proposals/Suggestions in my tenure for which the leather industry awaited since long:

#### 1) Inclusion of Leather in 2nd Phase of China-Pak FTA:

I would like to share that 2nd Phase of China-Pak FTA has been finalized and effective from 1st December'2019 included Leather H.S. codes as mentioned below, for duty free import of finished leather of Cow, Buffalo, Sheep & Goat Skins into China from Pakistan, which is a great source of motivation with facilitation to our member exporters for further strengthening the bilateral trade relations between the two neighbor brother countries in general and to facilitate the leather shoes, leather garments, products etc., manufacturers based in China to make more competitive prices of products for export to the world with the innovative/finest quality of finished leather of Pakistani Origin at zero rated facility from Pakistan into China:-

### 2) Up-ward Revision Of Duty Drawback Rates On Finished Leather Notified Vide SRO 460(I)/2020 Dated 20th May '2020

I would to apprise you with pleasure that in response to PTA's hectic persuasion, the Government has finally accepted our genuine long pending demand for up-ward revision of Duty Drawback Rates on Finished Leather. Now the FBR has issued SRO 460(I)/2020 dated 20th May'2020 for up-ward revision of DDB on Finished Leather of all sorts effective from 20th May'2020. A comparative view of DDB Rats on Finished Leather is furnished herewith at a glance:

#### 3) To Control Smuggling of Live Animals

We strongly took up the matter on extreme shortage of livestock and brought to the notice of the Prime Ministry of Pakistan regarding smuggling of live animals to Afghanistan & Iran and requested to take steps to control the animal smuggling which directly affected Leather and allied industry resulting in price hike of meat, shortage of animals in local markets and shortage of raw materials for tanning industry, Leather Garments, Leather Shoes, Sports & goods.

On our request, the Secretary, Prime Minister of Pakistan office issued directives through letter No.42/M/SPM/2020 dated 3rd January'2020 to all relevant Federal/Provincial agencies to take notice and monitor to curb this phenomena.

#### 4) INCENTIVES ANNOUNCED IN FEDERAL BUDGET 2020-2021

• **REDUCTION OF CD & ACD ON TANNING CHEMICALS**On our demand, Government announced reduction in Customs Duty and Additional Custom Duty on the following 2-Tanning Chemicals in the Federal Budget 2020-21:

- REDUCTION OF CUSTOM DUTY ON 40 RAW MATERIALS OF VARIOUS INDUSTRIES.
- TARIFF RATIONALIZATION UNDER NATIONAL TARIFF POLICY 2019, BY REDUCING CUSTOMS DUTY ON 90 TARIFF LIMES FROM 11% TO 3% AND 0%.
- 5) IMMEDIATE ACTION TAKEN FOR RELEASING IMPORT SHIPMENTS OF PICKLED WETBLUE OF COW/BUFFALO HIDES & SKINS AS STICK-UP AT PORTS DUE TO CORONA VIRUS AND BAN ON IMPORT OF ZOONOTIC FROM CHINA

Due to PTA active persuasion in the matter of very significant in nature, the Government ultimately allowed PTA members to import of Pickled/Wetblue cow/buffalo hides and goat/sheep skins from China with the submission of "Quarantine Certificate" as these materials are already processed with necessary due Chemicals to become it Wetblue Leather and preserved these materials for the Leather Industry for further value addition and certainly these materials are "Free from all deceases including Corona Virus".

#### 6) REFUND OF SALES TAX, INCOME TAX AND DUTY DRAWBACK CLAIMS

Due to continue follow-up the Government has decided to take measures for speedy payment of refunds through creation of a "Refund Fund" for payment of pending Income Tax Refunds.

Regarding refund of Sales Tax and Duty Drawback claims, government assured exporters concerned for early release of all pending claims for revival and sustainable economic growth which was badly affected by COVID-19.

#### Leather Industry's proposals/suggestions for Federal Budget 2020-21

To include "Dyed / Finished Leather" with the following H.S codes in the new DLTL Scheme announced vide SRO # 711(I)/2018 dated 08.06.2018 for which it was ensured categorically by MOC to PTA for the inclusion but not yet implemented unfortunately. The finished leather was earlier included in DTLTL and unilaterally eliminated from the new scheme for 2018-21:
H.S. Codes # 4107.1200 / 4107.9200 / 4107.9100 / 4112.000 / 4113.9000 & 4113.1000
Tariff rationalization as per Annexure A as annexed below, which is ranging from 2% to 7% on import of basic tanning chemicals & Machineries for the Industry. It is recommended in the sheet to abolish ACD and also rationalization of CD on basic chemicals which are only used in tanning industry for finished leather production to reduce cost of production which has become too high in comparison with the neighbor competing countries to provide level playing to this industry to compete in international market effectively.
The Government has removed 4% Customs Duty on import of Tanning Machinery but still 10% on Sales Tax is charged on import of tanning machinery added with indemnity bond of 7%. But recently introduced 5% AGST on import of Machinery, which may please be removed otherwise the incentive for removal of 4% custom duty will be wasted.
To remove 10% sales tax on import of tanning machinery. This will help us to import latest technology to upgrade our industry. However, if removal of 10% sales tax is not possible in such case we suggest indemnity bond for whole 17% to save us from cash flow problem.
To allocate desired fund for Rs.133 Million out of total expenditure for Rs.485 Million for organizing 10-12 Int'l Leather Fairs by PTA around the globe with Government financial assistance for participation of PTA's members IRRESPECTIVE OF 2 TIMES & 5 YEARS PARTICIPATION CONDITION. THE REQUEST HAS ALREADY BEEN APPROVED BY HONOURABLE ADVISOR TO PM ON COMMERCE & TEXTILE, MR. ABDUL RAZZAK DAWOOD DURING A MEETING HELD WITH PTA'S DELEGATION ON 02.01.2020 AT ISLAMABAD.
To consider favorably to reinstate the SRO # 1125 to allow Leather Sector of Pakistan at Zero Rated status as was allowed previously, which is 95% export oriented Sector of the country duly documented.
Revision of SRO # 578 for the import of Tanning Machineries with Government financial incentives with relaxed mode for which submission was already made to MOC, Islamabad.
To declare officially Raw Hides & Skins as Agricultural Produce item and Sale of Raw Hides & skins should be considered as "Agriculture Income" under Section 41 of ITO 2001 and be exempted from levy of withholding tax. It is clarified here that Raw Hides/ Hides and Skins (Dry and Wet) are already included in the definition of Agriculture Produce as per the Punjab Agricultural Produce markets Ordinance, 1978.

#### LEATHER INDUSTRY'S PROPOSALS FOR TRADE POLICY 2020-2023

To allow 75% Matching Grant for setting-up of Effluent Treatment Plants in Individual Tanneries which is a fundamental requirement for enrolling our member exporters in LWG:

- a) Approximate No. of Interested Individual Tanneries in Pakistan: 20-25
- b) Approximate for budget for Effluent Treatment Plants: Pak Rs.500 to Pak Rs.700 Million.

To allow 75% Govt., subsidy on International Lab Testing for Leather which is a prerequisite of Foreign buyers/brands for selling the finished leather to them.

#### LEATHER INDUSTRY'S PROPOSALS ROUTED THROUGH EDF-MINISTRY OF COMMERCE FOR APPROVAL

Besides, following Proposals submitted to EDF Secretariat also need attention for the approval early without further delay for the supreme motive to facilitate PTA member exporters :

- a) Allocation of required fund for Rs.133 Million for participation of our member exporters in International Leather Fairs around the globe as per proposals already submitted by PTA with all pre-requisitions in general and prescribed EDF form in particularly duly filled-in.
- b) Allocation of required fund for Rs.300 Million for the Air Freight subsidy on exorbitant charges being charged by foreign airlines for the export shipments by AIR during COVID-19 pandemic and the proposals with all required documents had also been submitted to TDAP, Karachi for recommendation to EDF Secretariat for further proceeding.
- c) To grant 75% amounting to Rs.180 Million for 3-years Government financial support from EDF for Int'l Lab Testing of Leather which is a of Foreign buyers/brands for selling the finished leather to them while the same facility has already been extending by EDF to Leather Garments Manufacturers-Exporters and the mother tanning industry Finished Leather is still deprived from this incentive as originally claimed by PTA for its members exporters.

#### Chronicle Events & Meetings 2019-2020

Following Meetings were held during my Chairmanship with respective organizations and government authorities concerned, outcome of these meetings are as follows:

#### 01. PTA Delegation held Meeting with CE-TDAP on 24th October'2019.

PTA Delegation led by me accompanied by Mr. Muhammad Shafi, Vice Chairman, PTA (Central), Mr. Amanullah Aftab, Chairman, Int'l Fairs Standing Committee, PTA, Mr. Gulzar Firoz, Ex-Chairman, PTA, Mr. Kamran Habib, CEC Member and Mr. Shafique Ahmed held a meeting with Chief Executive, TDAP, Mr. Arif Ahmed Khan to discuss all related issues particularly for the implementation of 80% subsidy on Int'l Fairs, release of amount for 4th PMLS and 5th PMLS and release of 25% balance amount for setting-up of Effluent Treatment Plants in individual tanneries. Following Agenda was discussed during the meeting:

To confirm for the implementation of approval/decision for releasing 80% Government subsidy on participation of Int'l Leather Fairs IRRESPECTIVE OF 5 YEARS PARTICIPATION & 2 TIMES PARTICIPATION IN A YEAR, as already approved by MOC vide its enclosed letter alongwith PTA's original proposal letter dated 16.09.2019.
Release of subsidy amount to the tune of Rs.20 Million already available in PTA/TDAP's joint account in NBP, Karachi for 4th PMLS'2018 at Lahore.
Expedite the process for releasing approved amount of Rs.20 Million for 5th PMLS'2019, Lahore for which submission has already been made to TDAP.
Release of Rs.20 Million for the treatment plants receivable from TDAP for 8 member firms.
Any other matter with the permission of the chair.

The discussion concluded positively on all matters and assured to make it resolve shortly and release the pending for the leather show shortly subject to the clearance & further information. As regard the pending amount for treatment plants, CE/TDAP has assured to make arrangements for the meeting with DG/FIA, who is newly appointed to sort out this issue for PTA member's amount. Besides, PTA Central is following up the matter vigorously till resolution of all related issues with TDAP and certainly to update the members in due course.

PTA delegation led by comparing Mr. Fazalur Rehman Sheikh, Sr. Vice Chairman, Mr. Muhammad Shafi, Vice Chairman, PTA (Central), Mr. Agha Saiddain, Ex-Chairman, PTA, Kh. Muhammad Mehr Ali and Mr. Hamid Arshad Zahur, Members PTA met with Chairman, FBR, Syed Muhammad Shabbar Zaidi on 29th November'2019 at FBR, Islamabad to discuss the core issues of Leather Industry being faced by its member exporters i.e. i) Fixation of Benchmark/Ceiling at least 10% as per working of PTA for refund of Sales Tax for Finished Leather through FASTER System ii) To allow rate of DDB for finished leather for cow/ buffalo Hides and sheep/goat skins as was already approved by IOCO instead of existing rates iii) Withdrawal of SRO # 327, which was revoked recently by FBR un-necessarily, for the import of required raw materials for the leather Industry for meeting the consumption requirement for export purpose to earn sizeable foreign exchange for the country iv) Withdrawal of 2%ACD on import of Cow & Buffalo v) Acceptance of Indemnity Bond for 17% Sales Tax rather than payment of 7% cash & 10% indemnity Bond for the import of Tanning Machineries for the up gradation of the Industry.

Chairman, FBR heard patiently issues of Leather Industry and assured the delegation for resolution as soon as possible.

Muhammad Mehr Ali and Mr. Muhammad Ali-SG, PTA met Mr. Abdul Razak Dawood, Advisor to PM on Commerce on 2nd January'2020 in Ministry of Commerce, Islamabad to discuss following core issues being confronted by the Leather Industry:

- To control smuggling of Livestock from Pakistan to Afghanistan & Iran,
- To rationalization Tariff of CD, ACD, ST/AGST etc., etc.
- To release DLTL refund claims to Leather Sector.
- To include Finished Leather/Dyed leather in new DLTL 2018-2021.
- To grant fund for Rs.133 Million out of total expenditure for Rs.485 Million for organizing 10-Int'l Fairs as allocated by TDAP to PTA's Member Participants.
- To Compliance / NEQS.
- To announce Technology Up-gradation Programme by the MoC.
- To adopt No-Duty No-Drawback System.



In due deliberation, a detailed power point presentation was delivered by Mr. Agha Saiddain, Ex-Chairman, PTA to the Advisor on Commerce wherein highlighted all areas of the leather sector specially Finished Leather plight which was highly appreciated by the House particularly the Advisor on Commerce who seen each page of presentation carefully and got the clarification which was given by Mr. Agha Saiddain to him with satisfaction.





At the conclusion of the meeting Mr. Abdul Razak Dawood, Advisor on Commerce shown his intension to give priority to Leather Sector of Pakistan which is a core industry of the country and assured to extend all maximum possible cooperation for the survival of this Industry and realized the great potentials for the expansion & promotion of Leather exports.

He also informed that the MoC is being finalized the formation of Leather Export Promotion Council (LEPC) as per mutual understanding agreement between all stakeholders of Leather Sector and inviting 6 names from PTA for finished leather for inclusion in the proposed LEPC to proceed further in this regard to become it effective for leather sector of Pakistan.

- To withdraw ban import of Pickled/Wetblue Cow/Buffalo Hides & Goat Skins: The Advisor on Commerce issues instruction to the Official concerned for immediate removal of the ban imposed unnecessarily. Accordingly, the Ministry of National Health Services, Regulation and Coordination and Ministry of Commerce issued Officials Memorandum and clarification vide their letter dated 25th& 26th February respectively in this regard for removal of ban on import of pickled/wetblue cow/buffalo hides & goat skins from China.

Mr. Fazalur Rehman Shaikh, Sr. Vice Chairman, PTA Central participated in the Master Training Session arranged by the Ministry of Commerce at NADRA Office, Islamabad on 3rd March'2020 for launching e-business visa invitation letter wherein all associations/chambers were invited and PTA was included in group C between 6PM to 8 PM. He got the basic information for the new software for issuance of E-Business invitation letter to be issued by PTA thru automatic software with the affiliation of NADRA software under the banner of DGTO/MOC for which requisition is to allot separate ID & password thru a separate designated e.mail ID to be generated by PTA for E-Business invitation letter to the foreign buyers/customers in particular for which PTA Central Secretariat is making further coordination in this regard to enroll PTA in the software of NADRA for the desired issuance with the special software to be finalised by NADRA.

#### 14. MR. HAMID ARSHAD ZAHUR, MEMBER, PTA MET DG-IOCO ON 05.03.2020 AT KARACHI

As nominated by me in consultation with Mr. Anjum Zafar, Mr. Hamid Arshad Zahur met DG, IOCO on 5th March'2020 at Custom House, Karachi to discuss and finalize upward revision of Duty Drawback Rates on Finished Leather as prepared by Mr. Anjum Zafar, Chairman, Duty & Taxes Standing Committee, PTA.

#### 15. PTA Delegation meeting with Secretary, TDAP on 05.03.2020

A meeting of PTA Delegation comprising Mr. Amanullah Aftab, Chairman, International Fairs & Exhibitions Standing Committee, PTA, Mr. Gulzar Firoz, Mr. Shafique Ahmed and Mr. Muhammad Ali held with Secretary, TDAP, Mr. M. Sualeh A. Faruqui on 05-03-2020 to discuss one point agenda for the increase in Budget for Int'l Fairs participation being organised by PTA for its members participation, as initially TDAP has proposed to allocate only Rs.4.5 Million against total requisition of PTA Rs.55 Million for 7 int'l regular, which is completely insufficient for the Fairs of our members. After detailed discussion made thereon during meeting in TDAP's office Karachi, the Secretary TDAP has approved more subsidy amount which worth around Rs.10 Million + Rs.4.5 Million allocated to PTA totaling to Pak Rs.14.5 Million as exceptionally for those which are held on or before June'2020, while remaining fairs June'2020 onward, it was assured to PTA's Delegation to accommodate them also as TDAP is in progress to yield Extra Grant from EDF Board and also from World Bank and he also assured to arrange another meeting for remaining Fairs in June'2020 onward expected to be held in April'2020 to finalise the remaining list of fairs with Government subsidy, it is optimistic to get the subsidy continued from TDAP in future for remaining Int'l Fairs for participation of PTA's members, which is vital tool for marketing & promotion of trade under these recession circumstances. The Secretary, TDAP also informed to the Delegation all those events which were already organized by PTA by Dec'2019 such as ACLE'2020, Shanghai, Lineapelle Fair, Oct'2019 and Leathertech, Nov'2020, Bangladesh and their subsidies already are in progress with final mode would be released to PTA shortly for onward disbursement.



# 16. Mr. Gulzar Firoz, Senior Member PTA and Member Board of Director of TDAP attended meeting of BOD of TDAP on 07.03.2020

Mr. Gulzar Firoz, Senior Member, PTA and Membert, Board of Directors of TDAP had taken-up strongly during the meeting of BOD of TDAP on 07-03-2020 the important matter for the removal of 2 times & 5 years participation of PTA's members in International Fairs as allocated by TDAP to PTA and very confident it may be effected/implemented after completion of due process of TDAP shortly.

## 17. Meeting with Mr. Abdul Razak Dawood, Advisor to PM on Commerce through Video Link on 16.03.2020 at TDAP, Karachi

I alongwith Mr. Muhammad Ali, SG, PTA attended an emergent meeting held in TDAP, Karachi, which was chaired by Mr. Abdul Razak Dawood, Advisor to PM on Commerce through video link on 16th March'2020 wherein all core export sectors' representatives were invited.

The objective of the meeting was to discuss the dismal situation of economy/exports in result of Corona Virus and the majority participants were from Textile and informed their grievances to the Advisor Sahib and most of them are common with Leather sector also such as 1) Severe Liquidity Crunches in view of cancellation of orders facing by the textile sector in particular, inventories which are already piled up at huge extent and how to sustain it without cash flow, Labor, currency fluctuations in Pakistan in US\$ and many more vital issues and accordingly with consensus submitted the following proposals for immediate resolution with relief to all core sectors of the country including Leather Sector of Pakistan, which is also severe crisis:-

- a) Immediate release of Sales Tax, Income Tax & Duty Drawback claims to the exporters to clear all the pendency till today to equip the exporters financially under the prevailing business circumstances.
- b) The period of ERS should be increased from 180 Days to atleast 360 380 days.
- c) To reinstate all five sectors status @ zero Rate atleast for 1 year.
- d) DTRE scheme period should be increased from 12 months to 24 months with more relaxed mode.
- e) Removal of collection of EDS @ 0.25% atleast for 3 years.

I being chairman, PTA strongly emphasized the need for the following:-

- 01. To release the Sales Tax/ Income Tax & Duty drawback claims to PTA's member exporters IMMEDIATELY.
- 02. To include Dyed/Finished Leather in the new DLTL scheme for 2018-21 thru SRO for which the attention was specially invited of Advisor Sahib in reference to all previous meetings held by PTA's Delegation particularly last meeting held on 02.01.2020 at MOC, Islamabad wherein he again categorically assured for the inclusion of dyed/finished leather in the new DLTL scheme as was occurred mistakenly. Accordingly the Advisor to PM, Mr. Abdul Razak has shown deep resentment to Secretary, MOC, Mr. Sardar Ahmed Sukhera during the meeting and inquired as to why the implementation to the

decision has not yet been made for the desired inclusion for which Secretary, MOC has assured to the Chairman, PTA during meeting to coordinate with him for the inclusion.

- 03. I also raised the question for the removal of AGST & ACD, which are completely irrational/illogical when the Government is collecting the CD & GST, which was also realized by Advisor Sahib during the meeting held with him on 02.01.2020 at MOC, Islamabad for which he firmly assured for the removal.
- 04. I also pointed out the release of DLTL Claims for the incremental exports, which is still pending with SBP, which should also be released to PTA's member exporters.
- 05. I also raised the proposal to consider to make necessary Cut on "Interest Rate" as has already been announced major countries of the world specially USA.

While concluding, it was generated view/consent of the House that Government/MOC must decide on war footing basis without delay to give maximum relief under these peculiar nature circumstances where all the countries are offering maximum incentives to their export industries to save from the crisis.

I am chasing all the above matter specially inclusion of "Dyed/finished leather" in the new DLTL very vigorously with Secretary, MOC for early inclusion with rest of our issues and confident to yield the desired objectives with all members support specially Senior Members.



#### 18. Meeting with Chemicals Supplier on 30.04.2020 at PTA Central Office, Karachi.

I arranged a meeting first time with Sole Representatives/Agents of Chemicals Suppliers through Video Conference simultaneously at PTA Central Office, Karachi & PTA Northern Zone Office, Lahore on 30th April'2020 to discuss economical situation affected due to COVID-19 outbreak in the country and its negative impact brought to Leather Industry and consider how future course of action would be adopted in these critical days.

During the Meeting Chairman, PTA with consensus of PTA members requested the Chemicals representatives to coordinate with their foreign principals / counterparts for suitable reduction in Tanning Chemicals prices in wake of Covid-19 Pandemic and requested them to recommend PTA's proposal as already moved to the Ministry of Commerce and FBR for removal OR at atleast 50% reduction in AGST & ACD on basic Tanning Chemicals which are produced locally as per REACH compliance.



#### 19. PTA Delegation Meeting held with Acting Secretary, TDAP on 3rd July'2020

PTA's Delegation led by me alongwith Vice Chairman, PTA, Mr. Muhammad Shafi and Mr. Amanullah Aftab, Chairman, Int'l Fairs held meeting with Acting Secretary, TDAP, Mr. Riaz Ahmed Sheikh in his office at TDAP, Karachi on 3rd July'2020 to discuss following core issues:

#### a) Subsidy on higher Air Freight charges for Leather export shipments during COVID:

PTA proposal already submitted to MoC and also sent to TDAP alongwith others proposals for recommendation to MoC for extending subsidy on Higher Air Freight Charges of Airlines concerned being charges on export cargo, for which the Acting Secretary, TDAP agreed to proceed with MOC for getting its approval for extending financial support to PTA's members with the fixation of Air Freight subsidy sector wise with certain quantum of amount in US\$/Euro for each shipment as has been made for other commodities.



#### b) Allocation of Int'l Fairs to PTA effective from Nov'2020 to June'2021

PTA has already submitted its short listed list of Int'l Fairs upto 05 (Five) for the allocation with increased subsidy percentage @ 75% irrespective of 5 years & 2 times participation condition, which is completely irrational & detrimental under the prevailing circumstances of COVID-19. PTA confidents that the allocation of short listed 5 Fairs would be justified with the following facts:

• All the activities of marketing & participation in Int'l fairs either by TDAP or PTA have been stopped during the current year, resultantly to save the entire budget of TDAP for marketing & participation and hope to be available with TDAP for allocation of remaining fairs effective from Nov'2020.

- An amount of Rs.10 Million has already been approved exceptionally by Ex-Secretary, TDAP during the meeting held with PTA's Delegation on 05.03.2020 for participation in APLF'2020 (March), Hong Kong, which has also not been utilized by PTA as the fair has been cancelled thereafter, which is also saved and would be available with TDAP for utilization.
- It was also assured to PTA's delegation during the meeting held on 05.03.2020 that the remaining Int'l fairs for leather would also be considered positively for the allocation to PTA.

# 20. PTA Delegation Meeting held with the Advisor to PM on Commerce on 6th July'2020 at Ministry of Commerce, Islamabad

PTA's Delegation led by me comprising Mr. Agha Saiddain and Mr. Anjum Zafar held an emergent meeting with Mr. Abdul Razak Dawood, Advisor to PM on Commerce at Ministry of Commerce, Islamabad on 6th July'2020 with his team consisting of Mr. M. Ishfaq Khan, Joint Secretary, MOC & Mr. Waqas Azeem, DG (Trade Policy), MOC to discuss the following core issues for Leather Sector of Pakistan for the desired resolution:

- Re-inclusion of "Dyed/Finished Leather" in the NEW DLTL SCHEME for the year 2018-21 with all related H.S. codes.
- Subsidy on Air Freight Charges under COVID-19.

- Relaxation of Duty Structure on REMAINING 6 basic Tanning Chemicals for Leather Industry out of total 8 short listed already submitted to MOC earlier. It was firmly assured by Advisor to PM numerously orally for ensure inclusion of all 8 H.S. codes, but unfortunately 6 H.S. codes are not entertained out of 8 short listed.
- Issuance of Exemption Certificates against 2% Withholding Tax on import of basic raw materials with restoration of Commissioner's power against Clause # 72B, which is revoked for PTA's member exporters whose exports NOT less than 80% as was in practice earlier.
- Request for removal of 3% AGST & increased percentage of Income Tax from 2% to 5.5% imposed on Commercial Importers for Leather Industry, who are allied supplier of the Industry to cater to the needs of the Industry for value addition, resultantly the exporters would be affected severely with increase of production cos, which is already on higher side in comparison with regional competitors.
- Re-Assurance for the removal of existing 20% Custom duty on import of basic raw materials (Raw Hides & skins/Wet blue Leather) in the wake of GSP +.
- To consider to remove the requirement for issuance of "Quarantine Certificate" against the SRO # 1067 on import of basic Raw Materials for the Leather Industry.
- 75% subsidy on participation of PTA's members in International Leather Fairs around the globe.

Regarding PTA's proposal for increasing in percentage of subsidy @75% for participation of PTA member exporters in all upcoming Int'l Fairs, he apprised PTA Delegation that most of the International Fairs had already been cancelled this year due to COVID-19 outbreak all over the World and the proposal would be considered for the next year 2021 with the desired allocation & implementation.

I alongwith my team comprising Mr. Anjum Zafar from Lahore, Kh. Muhammad Mehr Ali from Multan and Mr. Amjad Hafeez and Mr. Hamid Arshad Zahur from Karachi participating in the Interactive Session organized by TDAP through ZOOM Software on 6th August'2020 under the Chairmanship of Mr. Basit Rauf, Director General, TDAP to discuss PTA proposals for recommendation and inclusion in the forthcoming Strategic Trade Policy Framework 2020-25.

It was shared with the House that the submission of short listed 8 H.S. codes for Tanning Industry was submitted to MOC thru Late Mr. Ali Habib, Chairman, Task Force on instance of Advisor to PM and despite firm assurances made to PTA ONLY slight reduction was made for Two Chemicals while remaining 6 H.S. codes were remaining unchanged, which was really repugnant to the aspiration & commitment made with PTA. It was also clarified here that the local production of Chromium sulphate is completely negligible quantum in Pakistan which is around less than 10% than total demand/requirement of the Industry while the below cogent reasons for Locally produced chromium sulphate are also main obstacles for NOT utilization by the Tanning Industry as highlighted already in the prescribed format:  a) Not REACH compliance, which is utmost imperative as required by foreign buyers/customers specially Europe.  b) Qty as required by the Industry is not available as being produced by them locally in Pakistan, which could be less than 10% than the total 100% requirement of the Tanning Industry.  c) Most importantly Quality with consistency is not being
		produced by local manufacturers, which varies the production of finished leather owing to non consistency &quality resultantly the foreign buyers/customers rejects the finished leather shipments.

02. Accordingly it was assured again to PTA for strong recommendation for the inclusion in the new DLTL scheme with all related 6 H.S. codes

### 22. PTA Delegation Meeting held with Mr. Abdul Razak Dawood, Advisor to PM on Commerce in MoC on 20th August'2020

In pursuance of our previous meeting held with the Advisor to PM on Commerce of 6th July'2020, I alongwith Mr. Anjum Zafar, Senior Member, PTA met Mr. Abdul Razak Dawood, Advisor to PM on Commerce in Ministry of Commerce, Islamabad on 20th August'2020 to disccuss and recall for implementation of the decisions taken in the previous meeting with PTA delegation specially to discuss specific core issues particularly inclusion of Leather in New DLTL scheme. During meeting it has been clarified in detail to the reservations/confusion/mis-perception of MOC and rest of officials of MOC to the importance for the inclusion of dyed/finished leather and after threatbare discussion comprehensively, they were found convinced as felt during the meeting for the productivity & potentiality of finished leather's inclusion in the DLTL scheme 2018-21 for which PTA assured them if any further query/clarification of any further Ministry/department is required in this behalf PTA is ready to hold another session of meeting physically at any time in Islamabad OR at Zoom link for which Mr. Abdul Razak Dawood informed to revert back to PTA shortly in this regard to finalise this long pending issue of Tanning Industry.

It was also confirmed the SRO/Notification for "Removal of Condition of Quarantine Certificate" for imported raw materials would shortly be issued as all procedures have been completed for issuance.

# 23. Meeting of Business Community including Leather held with COAS General Qamar Bajwa on 2nd September'2020 at Karachi

I participated in a high level meeting in Karachi on 2nd September'2020 which was chaired by Honourable Chief of Army Staff, General Qamar Javed Bajwa and also attended by Core Commander Sindh, Mr. Humayun Aziz and many more government officials alongwith business community persons from different Associations, Federation, Chambers.

Outcome of the meeting was very productive, which was prolonged around 4hrs started from 10:30 am till 2:30 Pm to discuss all core issues related to the Industries & Karachi city torrential rains. I represented Leather Sector (Tanning Industry) & submitted PTA proposals/demands specially the problems / pending issues with MOC/FBR 1) Inclusion of Dyed/Finished Leather in DLTL 2) Rationalization of Duty slabs on basic Tanning Chemicals, Machineries particularly ACD, AGST 3) Issuance of STPF without further delay with our demand for 75% subsidy on individual treatment plants 4) 75% on Int'l Lab testing for Leather and some other related issues and it was firmly assured by Chief of Army Staff and Core Commander Sindh to get the desired inclusion of dyed/finished leather in the New DLTL scheme and he

will direct to Mr. Abdul Razaq Dawood, Advisor to PM on Commerce with resolution of rest of the issues of Leather Industry.

The matter for the infrastructure of Karachi was also discussed very strongly specially Korangi Industrial Area (Sector 7A), Karachi for which a presentation has also been submitted to them by me with proposal for amelioration of vicinity/area of Sector 7-A with basic facilities & upgrade the area, it has been realized that the enthusiasm from the Army side was very high for providing all maximum facilities to the Industries specially Leather Sector to promote the exports maximum for which I finally asked during the meeting to provide the genuine demands of the Industry ATLEAST as are fundamental with required level playing field in comparison with neighbor competitors like India, Bangladesh & China so that the desired objectives for the promotion of exports would definitely be achieved by all export sectors including Leather Sector of Pakistan.

While conclusion, I strongly appealed for the resolution of issues for Leather Sector as already submitted in writing and problems being faced by Karachi, which is of course financial hub for Pakistan and I am confident that this time the positive response could be revealed for the betterment of the Leather Industry, Karachi & country as well.

#### 24. PTA Delegation Meeting held with the CE-TDAP on 7th September'2020 at Karachi

PTA Delegation led by me accompanied by Mr. Muhammad Shafi, Vice Chairman, PTA, Mr. Abdul Salam, Senior Member, PTA met Mr. Arif Ali Khan, Chief Executive, TDAP and his team to discuss core issues of the Leather Industry which were as (1) inclusion of Dyed/finished leather in the new DLTL scheme for the year 2018-21 for which a comprehensive discussion was made with all facts & figures to realise the gravity and importance of MOST VALUE ADDED PRODUCT of finished leather and convinced them finally for his strong recommendation to the Ministry for the desired inclusion as was eliminated unilaterally by MOC without any consultation with PTA/stakeholders wherein it was shared with the statistics of export of leather which is gradually decreasing drastically particularly in the Month of July'2020 in comparison in absence of this facility to leather exporters/PTA's member exporters as rest of commodities are availing this facility including the similar product of textile sector "Dyed/Printed Fabrics" in the new DLTL scheme and finally the TDAP's authority was fully convinced with PTA's arguments for its recommendation to MOC for the inclusion (2) Release of subsidy for Air Freight during COVID-19 for Rs.300 Million as already submitted to TDAP and EDF (3) Rationalisation of Duty Structure on basic tanning chemicals to Tanning Industry as only in recent Budget slight relief was made/offered only on 2 Chemicals while remaining 6 H.S. codes for Tanning Chemicals are remain unchanged, which are vital for the Industry for facilitation for the reduction of product cost, which is much higher as compared to neighbour competitors countries also strongly highlighted the issue for Formic Acid for its duty structure and evaluation of import prices at Customs, which is burning issue as well (4) to release of pending amount in favour of 8-tanners concerned for establishment of Effluent Treatment Plant in individual Tanneries as announced in STPF 2009-12. (5) allocation of Int'l Fairs for wide marketing to PTA for the upcoming Months with release of one pending subsidy to PTA for onward disbursement for which needs to submit a fresh proposal with the adjustment of fairs to be made in next 2021 and proposal for release of pending subsidy for Lineapelle Fair, 2020 for which submitting a fresh proposal based on

today's decision besides highlighted also the issue for the subsidy on Int'l Lab testing for Leather for which a comprehensive proposal has also been submitted to EDF already. PTA's focal point during the meeting was the inclusion of dyed/finished leather in the DLTL scheme.







The Finance & Administration Standing Committee remained functional actively during the year under review headed by Sh. Afzal Hussain, Chairman, PTA, he actively examined the monthly accounts of PTA Central Office regularly with reference to Receipts & Expenditure and the overall fiscal position as compared to last month's account before taking-up the same in the Central Executive Committee's meetings for final review and approval.

All the financial transactions for the purpose of heavy remittance to international fairs organizers concerned or essential purchases etc. have been vetted, examined and recommended to ensure transparency and genuineness particularly from audit perspective and it is a healthy sign and our satisfaction that the Auditors (Chartered Accountants) have not so far raised any objection in respect of financial transaction and maintenance of accounts of PTA (Central). Besides most of the Int'l fairs have been cancelled this year owing to pandemic COVID-19.

With consensus of the EC members, PTA released @30% amounting to Rs.680,000/- to each Zone out of total net receipt of stand fee from PMLS-2020 at Lahore while the 1/3rd Obligatory fee from both the Zones for the year 2017-18 & 2018-19 has also been received/recovered/replenished by PTA Central to clear all the previous pendency in this account.

The Committee moved a proposal to CEC regarding to generate income for the Association as the business activities and export of Leather sector facing slow down in trade and cancellation of International Fairs at various destinations by the Fair Organizers concerned this year as these fairs allocated to PTA member participants by TDAP due to COVID-19 pandemic as affected globally, the Executive Committee with consensus decided to invest Rs.5 Million further in NBP on higher rate of interest help in day to day recurring expenditure of the Association.

#### IMPORT / CUSTOMS AFFAIRS STANDING COMMITTEE

Mr. Muhammad Afzal Hussain, Chairman, PTA also headed the Import / Customs Affairs Standing Committee of PTA during the year 2019-20. He actively took-up the matters of PTA Members regarding Import, Sales tax, Income Tax, Rebate Claims to Customs Authority Concerned for immediate resolution. As a result of persistent approached, some of the members have got their rebate claims.

He assessed and verified the prices of imported raw hides & skins and chemicals imported by our members concerned from various countries as and when they required to get certified from the Association for their onward submission to Customs to help releasing their import consignments without delay.

He actively intervene the matter regarding stuck-up import shipments of pickled/wetblue cow/buffalo hides and goat/sheep skins of PTA members from China due to ban on import of Zoontic Animals in wake of Corona Virus, he succeeded to get release these shipments on submission of Quarantine Certificate as these raw material have already have Chemicals process and free from harmful deceases.

He also taken-up following issues of PTA members with the high-ups for early resolution:

- Re-inclusion of "Dyed/Finished Leather" in the NEW DLTL SCHEME for the year 2018-21 with all related H.S. codes.
- Relaxation of Duty Structure on REMAINING 6 basic Tanning Chemicals for Leather Industry out
  of total 8 short listed already submitted to MOC earlier. It was firmly assured by Advisor to PM
  numerously orally for ensure inclusion of all 8 H.S. codes, but unfortunately 6 H.S. codes are not
  entertained out of 8 short listed.
- Issuance of Exemption Certificates against 2% Withholding Tax on import of basic raw materials with restoration of Commissioner's power against Clause # 72B, which is revoked for PTA's member exporters whose exports NOT less than 80% as was in practice earlier.
- Request for removal of 3% AGST & increased percentage of Income Tax from 2% to 5.5% imposed on Commercial Importers for Leather Industry, who are allied supplier of the Industry to cater to the needs of the Industry for value addition, resultantly the exporters would be affected severely with increase of production cos, which is already on higher side in comparison with regional competitors.

- Re-Assurance for the removal of existing 20% Custom duty on import of basic raw materials (Raw Hides & skins/Wet blue Leather) in the wake of GSP plus status.
- To consider to remove the requirement for issuance of "Quarantine Certificate" against the SRO # 1067 on import of basic Raw Materials for the Leather Industry

#### EXPORT AND TAXES STANDING COMMITTEE

Mr. Anjum Zafar was taken the portfolio of the Chairman of Export and Taxes Standing Committee of PTA (Central) in continuation for the year 2019-20 as well.

The significant achievement during this year was made for the approval of New Duty Drawback Rates for Finished Leather in all sorts, for which an hectic exercise with strong follow up was made for the revision of Duty Drawback rates based on existing scenario of duty structure in Pakistan as compared to previously, which was become due to be revised. Necessary physical visit to Karachi was also made to have a detailed meeting with DG/IOCO, Mr. Basit Choudhry and his team at Custom House, Karachi for finalizing the Duty Drawback Rates for Finished Leather. It is also shared that Finished Leather is the priority commodity to be the first one amongst 12 commodities of the country which was finalized with the new DDR and applied/approved with issuance of SRO # 460 for the implementation at ground effective from 21st June'2020 onward. I am thankful to the

Chairman, PTA Sheikh Afzal Hussain, Mr.Muhammad Musaddiq & Mr. Hamid Zahur for the exceptional assistance and rest of committee & senior members for providing helping hand with support for finalizing & approval of new DDR for finished leather. The New Chart of DDR in comparison is given below, which was already circulated amongst all country wide members with copy of SRO # 460:-

He is actively looking after the affairs of the Committee as detailed below and attended various meetings with the Chairman, PTA held with the high-ups:

01. He participated in the meeting held at PM house at Islamabad on 10.01.2020 where he strongly took up the matter and requested to control smuggling of livestock for our leather industry and gave concerns on extreme shortage as this will affect all leather and allied industry. The concerned Department have promptly issued instructions and which is being implemented in true spirit.

The Meeting was also attended by Mr. Abdul Razzak Dawood, Advisor to PM on Commerce and he told about this and PM instructed him to take action. Mr. Abdul Razzak Dawood also mentioned that UAE government has also taken large quantity of live animals from Pakistan which our Government had to allow due to special relations but other smuggling of live animals to Afghanistan and Iran can be controlled and he will take steps as assured in PM meeting.

Mr. Anjum Zafar also requested not to allow official export of live animals as it extremely short and actual live stock is less that 2006 as per in official statement of secretary live stock and PM was shocked on this.

Besides above, he also discussed some other important issues of Leather Industry specially removal of Custom Duty & ACD on Tanning Chemicals and Machinery.

02. He also joined PTA delegation led by Sh. Afzal Hussain, Chairman, PTA and met with Mr. Abdul Razak Dawood, Advisor to PM on Commerce & Textile and his team in Ministry of Commerce at Islamabad on July 6, 2020 to discuss core issues of the Leather Industry.

He emphasized for continue follow-up with the Ministry of Commerce and all government departments concerned for resolution / favourable consideration of PTA's genuine proposals pending since long.

Brief description of each Fair held from Sept'2017 to September, 2018 is highlighted hereunder :-

It is the 2nd time in consecutive that PTA had organized the National Pavilion for participation of its 13 interested members under the banner of National Pavilion of Pakistan in Leathertech held from 31st Oct to 2nd Nov., 2019 at Dhaka, Bangladesh, which was termed to be productive with the desired outcome of participation and all exhibitors have consented to continue for participation in next year at Dhaka, Bangladesh.



### Proposal moved by PTA to EDF for the financial support for participation of members in Int'l Leather Fairs from Export Development Fund (EDF)

PTA is persistently follow up the proposal with EDF for the approval and confident to get the positive result in this regard for the supreme motive to facilitate its country members for participation in International Leather Fairs with financial convenience without any hassle.





# Challenges Facing Leather Exports and the way out By Muhammad Musaddiq

Pakistan leather industry export of finish leather is on a constant decline for last 5 years and it has been hardly hit by covid-19 starting in March-20 just after the inspiring summer Lineapelle Italy, though the business activity in that fair was better than expected as it was held on the last date of the shoe fair Micam at the same premises. Then came covid-19 which stopped most of the commercial activities with respect to the leather products, trading, exports and imports on a worldwide scale. The lockdown across the world varied from country to country and city to city depending the prevalence of this pandemic.

In Pakistan Karachi city was under severe lockdown for many weeks, while in Punjab it was more relaxed under so called smart lockdown, so most of the tanneries were working on a slow pace in Punjab. Because of the closure of export markets due to this pandemic the demand of finish leather was going down, which resulting in decline of 29% in value of finish leather from Pakistan.

We know the various domestic reasons like high cost of chemicals, energy, labour and transportation cost, as well as high interest rates in Pakistan, which have been among the highest in the region. On top of that covid-19 almost killed the demand and markets were either closed or didn't have the demand of leather on their own.

Now we have to find out the way and solution that how to enhance our production and exports, so as to come back to the levels of as six to seven years ago. Of course it all depends on the global demands which is quite low at the moment but Pakistan leather export is already at fraction of 1% of the global leather market of finish leather, shoes, garments, bags etc, so to get more share of the world leather business is not impossible.

As long as the meat is eaten in the world hides and skins will be duly available as a bi product. Statistics shows that the level in consumption of meat is increasing worldwide, which will results in more hides and skins. As stated earlier Pakistan is a small player with respect to supply of finish leather and its products to the world and there is a big gap which can be filled up because of China factor.

China factor can be explained as the production of leather and its products are started to be decline because of:

- a) High ratio of import taxes from USA on Chinese imports
- b) High cost of production in china
- c) Geopolitical environment between china and west
- d) Free trade agreement between China and Pakistan
- e) Demoting the production of leather and expanding of new tanneries etc. As it wants to be move towards value addition technology and products

Now Pakistan has a positive chance to take some of the space in the world market by replacing chinses because of GSP and MFN status and even more exports to china because of new tariff agreement between china and Pakistan which has resulted zero percent duty on exports of Pakistani leather, shoes and other leather products on zero percent duty in to china.

The CPEC is going to give a lot of motivations for the enhancement of trade between China and Pakistan with better linking by highways and roads between the two countries. Thus facilitate cheaper and faster trade between both countries.

The geopolitical situation seems to favor Pakistani exports provided if the cost of the businesses and manufacturing of leather and leather products is controlled and can be competitive as per our Asian neighbors etc. etc.

But the most important challenge is there are the tanners, who have to create more demands of their leather which will help them to fight against synthetic materials, which has widely taking the place of leather market worldwide.

To that the further measures must be taken by Pakistani tanners;

- 1. Investment and RND
- 2. Use of Renewable Energy and improve down carbon foot prints
- 3. Conservation of Water by minimizing its use and recycling as much as possible
- 4. Improve in Efficiency and hiring of the work force to produce better quality of leather

All the above parameter should be regularly measures in terms of rupees per square feet and its cost should go down except RND expenses.

This can be done by putting targets say for the next five years what will be the cost in per square feet from the use of renewable energy, water conservation, recycling and hiring of work force. Cost of leather in per square feet should go down between twenty to thirty percent in next five years. And this is only possible by doing more investment in RND section by giving the right and provide detailed information to the customers, especially in EU and USA about the measures taken by the tanneries to improve that has been mentioned above like energy saving for better carbon foot prints, water conservation, better quality, new technology, chrome free water proof and other new tannages.

One can see even in Europe there are some tanners who have not been effected that badly in respect to reducing the value of their leathers, despite very high cost in Europe and they are the one who are following the measures which has been described as above.

### Finished Leather Safety Against COVID – 19 By Agha Saiddain

During May 2020, I decided to exchange my wild ideas with Mr. Mike Redwood heading "LEATHER NATURALLY" we started our discussion through emails and first thing to discuss was how long Corona Virus survive on various materials.

Interestingly Mr. Mike Redwood shared the information and following table was sufficient enough to get first hand knowledge about Corona Virus on various materials.

Then we decided to get an information about behavior of Corona Virus on finished leather of various types and can we develop Corona Resistant Leather (CRL) or Corona Proof Leather (CPL) or Corona Retardant Leather and Anti Corona Leather (ACL). Mr. Mike Redwood raised a question as why Corona Virus survive for 2-4 hours only on Aluminum and can we put something as surface coat on leather to match. He further said; "My thoughts have that until we have better treatment for sales over long term Anti Bacterial would be good, as long as no Covid-19 promise is made. If we find something better that would be excellent".

Research is still ongoing into many aspects including how long it can live on various surfaces. So far, two studies have been published on this topic. The first study was published in the New England Journal of Medicine (NEJM) for this study a standard amount of aerosolized virus was applied to different surfaces. The Second study was published in The Lancet. In this study, a droplet containing a set amount of virus was placed into a surface. In both studies the surfaces to which virus had been applied were incubated at room temperature. The study showed that following behavior on different materials.

The results of studies conducted by different laboratories differ slightly but variation is not much and trend line can be drawn to show average life of Covid – 19 on various surface.

The good news for Leather Sector is that Covid-19 survives longer on PVC and Plastic which have taken market in last few years. This can be taken strongly to create dissonance among the consumers against PVC and Plastics. PTA is in touch with Leather Naturally and discussion is on going process with Mr. Mike Redwood, Mr. Egbert and Myself.

The major issue to develop Covid-19 Free Leather is finances for research. Any positive break through can open a door for Natural Leather in Aviation and Auto Industry.

Hope our joint effort will bring positive results to promote Natural Leather and to reduce PVC and Plastic from Supply Chain of Footwear, Upholstery, and Aviation Leather.



# EXPORTS PERFORMANCE OF LEATHER & LEATHER PRODUCTS FROM PAKISTAN DURING JULY-JUNE 2019-2020 vis-à-vis 2018-19

The export of Leather and Leather Products for the financial year July-June 2019-20 touched US\$ 765.264 Million as against the performance of US\$ 844.384 Million in the corresponding period of last year and registered declined by 9.37%. Leather Sector's exports have fallen since March after the Government imposed a lockdown across the country to contain the COVID-19 Pandemic.

During July-June 2019-20 about 16.635 million square meters of finished leather was exported to Hong Kong, Italy, China, India, Vietnam, Korea, Germany, South Africa, Bangladesh, Spain, Turkey, Indonesia, USA, Portugal, Thailand, U.A.E., Poland and some other countries showing downfall of 22% in Volume & 27% in Value while the other sectors including Leather Garments exports posted a negative growth to US\$ 250.936 Mn in the fiscal year 2019-2020 as compared to US\$ 256,298 Mn in the corresponding period of last year and registered decline by 2.09%, Leather Gloves exports showing downward trend by 2.37% and other leather manufacturers by 10.05% while the Leather Footwear export registered positive trend by 0.66% in value reaching US\$ 107.170 Mn.

Just after easing of lockdown in the North American and European countries — top export destinations for Pakistani leather goods will help revive the sinking exports. The Covid-19 has collapsed the demand for country's exports during the last four-five months. However, there has been a revival in international orders for Pakistani products since June as a result the total export of Leather Sector revived in July-2020 increasing 9.33% year-on-year to US\$ 77.020 Mn as compare to US\$ 70.449 Mn in the corresponding month of last year, as data released by the Pakistan Bureau of Statistics.





The prestigious National Institute of Leather Technology (NILT) basically established in 1998 by PTA in financial collaboration of TDAP is now being managed under the independent Board of Governors. This institute housed in a splendid building in Korangi Industrial Area imparts technical and scientific training to the students as well as to the in-service technicians to enable them to serve the tanning, leather sector industry proficiently. Most of the members on the Board of Governors of NILT are from Pakistan Tanners Association who have been contributing their

tangible share to make it a state of the art institute aimed at upgrading qualitatively all the leather sectors to be competitive in the world market.

The National Institute of Leather Technology (NILT) is having a qualified faculty team to keep leather industry abreast with modern technology and practices as well as to provide a platform for human resource development. NILT was set up as an institute on national level of an international standard. This institute is planning to upgrade its status which needs full financial support from the Government.

NILT is affiliated and recognized by Sindh Board of Technical Education and Internationally by University of Northampton U.K. Presently Academic courses of DAE (3 Years), Executive Diploma (1 Year) and BBSYDP course (6 Months) are continued at the institution in addition to the college section classes which includes (Commerce, Computer Science, Pre-Medical and Pre- Engineering).

Moreover Principal and its team is also trying to improve educational standard of the students quantitatively and qualitatively. It is also expected that this year the new admission in DAE as well as in college will be more as compare to last year.

### **COMBINED EFFLUENT TREATMENT PLANT (CETP)**

The Combined Effluent Treatment Plant (CETP) for Korangi Tannery Cluster in Sector 6-C, Korangi Industrial Area, Karachi was set up with the cooperation of Pakistan and Dutch Governments as well as TDAP, Ministry of Commerce, Government of Sindh, City District Government and PTA (Southern Zone).



# INLAND REVENUE MATTERS WITH CORPORATE REGIONAL TAX OFFICE (CRTO) LAHORE

With the start of tenure, the Association kept close liaison with the Commissioner Zone VII CRTO Office Lahore. For zero-rating of electricity, Association office issued several certificate of recommendations to members for availing the facility announced by the government.

### PENDING CLAIMS OF CUSTOMS DUTY DRAWBACK

As per practice of previous years, PTA-NZ kept close interaction with Collectorate of Customs Lahore for early release of pending duty drawback claims. This year, FBR/Customs, as an administrative measure, posted Collector of Customs at Lahore Airport. I'm thankful to Mr. Anjum Zafar Convener Export, Taxes and Strategic Committee who remained in contact with the Collectorate of Customs, Allama Iqbal International Airport, Lahore.

Meanwhile, after lock down in March 2020, FBR received special budget from Ministry of Finance Government of Pakistan for the release of all pending duty drawback claims of eligible exporting sectors including the Leather. Hence, FBR arranged release of all pending duty drawback claims in WeBOC online.

In the pursuit of releasing duty drawback claims, Collectorate of Customs at Allama Iqbal International Airport (AIIAP) Lahore cancelled cheques worth 148 million on the instruction of FBR and referred the matter to FBR for online payments. These cheques pertain to eight exporting units out of which five aggrieved companies were members of PTA with huge refund amounts held up in these cancelled cheques. PTA Secretariat kept constant contact with authorities both at Collector Customs Lahore AIIAP and FBR Islamabad which stopped all payments of rebate claims.

Alhamdulillah, persistent follow-up and efforts bore fruits and PTA-NZ remained successful in the release of chequesfrom Collectorate of Customs, Lahore just before EidulAzha, the time when member tanneries require funds for purchasing.

We are thankful to PTA Central office Karachi for taking up the matter of pending customs rebates at Karachi ports. Patronage of Sheikh Afzal Hussain Chairman PTA along with support of senior members from Karachi needs special appreciation.

### **ACTIVITIES OF PTA-NZ DURING LOCKDOWN (MARCH – JUNE 2020)**

After the imposition of Lockdown in Punjab on 24th March 2020, all factories including tanneries were closed. Those member tannery units having export orders in processing and could not close immediately with the lock down orders, faced resistance from district administrative authorities. They approached the Association office seeking assistance to get permission to carry on their processes till the completion of their export orders.

Working X-office, PTA-NZ approached various offices ie. Ministry of Commerce, Chief Minister Punjab's office, Minister of Industries Punjab and Commissioner Lahore seeking permission for tanneries to complete their export orders.

Association office successfully engaged appointment with Commissioner Lahore for meeting in which Mr. AnjumZafar and Mr. Mansoor Iqbal participated. I'm very grateful to these senior members who successfully negotiated limited permission for tanneries around Lahore on the submission of undertaking to adopt and strict compliance of SOPs. Efforts of Mr. Agha Saiddain also need to be recognized here who, at a later stage, visited Commissioner Lahore during covid-19 peak and discussed the procedure for getting permission from Commissioner's office.

PTA-NZ also managed press releases in prominent newspapers nationwide highlighting the fact that if tanneries were not allowed to operate on limited scale, the precious hides and skins stock would start decaying and its economic impact would be show-up in the increase prices of meat.

### LIAISON WITH TRADE DEVELOPMENT AUTHORITY OF PAKISTAN, LAHORE OFFICE DURING LOCK DOWN

The cooperation and support extended by TDAP Lahore office during lock down days is appreciable. TDAP obtained list of exporting companies and their export orders detail and arranged exemption in a very quick manner. PTA-NZ Secretariat while working in close coordination with TDAP Lahore, facilitated the member units to get exemptions of industries during



lock down. In this regard, I also directed Secretary PTA-NZ for visiting Commissioner Office Lahoreand Deputy Commissioner office Lahore in order to seek support from these office to get necessary exemption orders for member units of Lahore.

### LIAISON WITH ZONAL OFFICE OF FEDERATION OF PAKISTAN CHAMBERS OF COMMERCE AND INDUSTRY (FPCCI)

Members of PTA-NZ represented and attended several meetings wherein voiced for different matters of our interest and benefit. The presence of PTA-NZ member at the platform of FPCCI is very important and it needs to be strengthened in future.

### LIAISON WITH LAHORE CHAMBER OF COMMERCE AND INDUSTRY

PTA-NZ has been maintaining close working relationship with Lahore Chamber of Commerce & Industry, Lahore Office. This relationship remained active in the period under report.

A team from Asian Development Bank visited Lahore Chamber of Commerce and Industry. The ADB Consulting team presented some concrete options for cooperation with the private sector regarding Skill Development in Punjab.

From PTA, Sheikh Muhammad Shafi, Executive Committee member and Secretary PTA-NZ participated in the meeting. Sheikh Muhammad Shafi presented the brief of leather industry in Pakistan and explained the present arrangements of training and skill development at Gujranwala Institute of Leather Technology and NILT Karachi. Sheikh Muhammad Shafi also invited the ADB team for a visit to NILT Karachi in order to assess gaps and modalities for improvement.

### LIAISON WITH STATE BANK OF PAKISTAN LAHORE OFFICE

State Bank of Pakistan is an important stakeholder institution for exports especially in the background of on-going DLTL schemes for boosting exports.

At different occasions, PTA-NZ apprised SBP Lahore and Multan authorities regarding difficulties that our members/exporters have been facing in getting DLTL payments. SBP authorities took up the matters and went for all possible resolution.

### HIDES AND SKINS PRESERVATION DURING EID-UL-AZHA

As per practice of previous years, PTA Northern Zone tried to activate and mobilize arrangement with Livestock and Dairy Development Department, Government of Punjab. Although our activities were limited during covid-19, however, Livestock Department Punjab remained in close coordination with PTA-NZ.

Livestock Department conducted a high level Stakeholder Consultative Session on the Meat Sector Development in Punjab. In this regard, I'm thankful to Mr. Agha Saiddain who joined in the sessionand expressed view point of Leather sector comprehensively.

Livestock Department also conducted social media campaign to avoid the losses occur to hides and skins collected during Eid days due to:

- Extreme hot weather
- Handling and transportation of hides and skins
- Late or no salting of hides and skins

Secretary PTA-NZ attended few meetings held in the office of Deputy Commissioner and Additional Deputy Commissioner to discuss Hides & Skin collection arrangements in Lahore City during Eid days to order to stream line the activities and affairs of Lahore Hide Market during EidulAzha.

### LIAISON AND WORKING WITH PTA CENTRAL

During the year under report, PTA-NZ Secretariat remained in active coordination with all activities at PTA Central. Members from PTA-Northern Zone joined Chairman PTA Central at several meetings arranged at Ministry of Commerce and FBR Islamabad. In this regard, I fully recognize the support of Mr. Anjum Zafar, Mr. Agha Saiddain and Khawaja Muhammad Mehr Ali who travelled to Islamabad several times to attend important meetings arranged by PTA Central office.

In addition, Joint Steering Committee for PMLS-2020 also arranged its several meetings in PTA-NZ office. PTA-NZ Secretariat spent a lot of its time and energy for bringing success in this mega event.

On 15th October 2019, PTA-Northern Zone office arranged and coordinated on Energy Management System (50001) & Environmental Management System (14001) for Leather sector in collaboration with SGS Pakistan, Lahore office. Representatives from as many as 12 member companies attended the session and termed it as very useful in understanding Energy Management System (50001) & Environmental Management System (14001). It was a 03 hours session focused on Basic Introduction of Energy Management System (50001) & Environmental Management System (14001).

### VISA RECOMMENDATORY AND OTHER CERTIFICATES/LETTERS

During the year under report, we have been issuing recommendatory certificates/ letters to our members or to their representatives, on the receipts of their formal request for the same, and requesting the Foreign Embassies – Consulate Generals for the grant of visa facilities to visit their countries for business tour to explore the possibilities for development of export trade. Generally these letters/ certificates are issued after thorough scrutiny.

### CORRESPONDENCE

The incoming queries have promptly been responded and the problems of the members brought into the notice of the concerned authorities. Besides the correspondence with the Government departments, Semi-government, other agencies, the Association also remained in touch with Central Office at Karachi

### FINANCE

The Statement of Accounts for the year 2019-2020 is presented before the house for its perusal and approval.

In addition to current bank balance, there is an amount of Rs.644,000/- receivable from Environmental Lab Society. Necessary arrangements are underway for the transfer of these amounts.

As regard to PTA claim against MCB, PTA-NZ has approached Civil Court through Mr. Agha I.A Imran Advocate who has been pleading the case at different forums earlier. It is pertinent to mention here that the Executive Committee has already decided to offer 25% of the recovered amount as his professional charges.

Case proceedings were filed in Civil Court in October 2010. Progress on suit filed against MCB in civil court is quite slow. Secretary PTA-NZ also visited court for appearance as witness. This year civil courts could not operate properly due to covid-19, therefore no court hearing was held after February 2020.

#### **MEMBERSHIP**

Presently, PTA-Northern Zone has 74 members on its register. Out of which, 58 are "Corporate" while 16 firms are registered in "Associate" class. During the year under report, following new members joined PTA-NZ as member of the Association:

### SECRETARIAT OF THE ASSOCIATION




