





First, I streamlined all the issues being faced by the tanning industry and sent comprehensive presentations to the Ministry of Commerce, Ministry of Finance, Federal Board of Revenue, Trade Development Authority of Pakistan, Export Development Board (EDF), MoC, IOCO and SBP for their pragmatic favourable consideration for the up-lift of leather Industry and inviting immediate attention for resolution of problems being faced by the exporters.

EXPORT PERFORMANCE

I would like to share the performance of Leather Sector of Pakistan which is now growing steadily after COVID-19 situation and registered remarkable exports at US\$ 953.707 Million during the current financial year July-June 2021-22 as compared to the last year's export at US\$ 832.824 Million with an increase of 14.51%. The Export of valued added Finished Leather registered positive growth of 28.50% and increased in Value of exports of Finished Leather at US\$ 208.092 Million as compared to last year export @ US\$ 161.940 Million. I hope the Leather Sector will achieve US\$ 1 Billion export in next year, Insha-Allah.

Role of Export Development Fund (EDF) – Ministry of Commerce

• Request for Allocation of Rs.12 Million for organizing of 7th Pakistan Mega Leather Show-2022.

(EDF approved amount of Rs.12 Million for 7th PMLS-2022 in its meeting held on 11.11.2021 which was returned to EDF as a good gesture due to less expenditure and curtail some expenses and postponed foreign delegation visits and Advertisement in Int'l Magazines etc.etc.as re-estimated in wake of COVID-19 crisis)

I appreciated the EDF for releasing fund through TDAP for organizing of 7th PMLS-2022 and expected to extend same support for the next 8th PMLS-2023 too.

- Request for 50% Subsidy (900 Million) for Establishment of Effluent Treatment Plants in Individual Tanneries in Pakistan submitted to EDF on 09.05.2022 (This proposal is under consideration by EDF)
- Request for approval of remaining 7-International Fairs for PTA's member exporters participation during the year 2022-23 with the remaining requisition of fund being 2nd Tranche for Rs.113.930 Million with 80% subsidy on stand cost as per PTA's original requisition of subsidy percentage instead of 25% submitted to EDF on 13.07.2022.

Besides above following proposals in hard copies were submitted to EDF for approval during the preceding year :

• Request for allocation of Fund Rs.133.00 Million out of EDF fund for PTA's member exporters participation in 10-International Fairs for wide marketing for the promotion of Leather export from Pakistan

PTA submitted a comprehensive proposal to EDF in 2020 and requested for allocation of fund of Rs.133.00 Million with 80% financial support from EDF for 10-International Fairs for participation of PTA's member exporters at various destinations for wide marketing internationally during the financial year July-June 2021-2022.

Alhamdulillah, the original proposal of PTA for allocation of fund for 10-International Fairs was approved by the EDF in its 20th Meeting of the Finance Committee under Agenda Item # 07 held on 16.06.2021 in principle and endorsed this decision in 22nd Meeting of the Finance Committee of the Board of Administrators of Export Development Fund (EDF) on 17.01.2022 in Ministry of Commerce, Islamabad and decided to approve initially first 3-Int'l Fairs at 25% subsidy on priority out of 10-Int'l Fairs. Accordingly, EDF approved 25% amount of "Stand Cost" for 3-International Fairs amounting to Rs.18,122,403/- with TDAP collaboration.

Initially, out of 3-approved International Fairs, PTA has already organized following 2-Intnational Fairs successfully while the approved subsidy of Rs.18.122 Million is still pending for the release at TDAP side despite all the formalities for opening of joint Account of TDAP/PTA has already been completed :

- Lineapelle Fair, Milan, Italy 22-24th February, 2022
- APLF-Dubai 30th March 2022, 1st April, 2022

Since then, PTA is still in constant contact with TDAP, and striving hard for the release of approved fund of Rs.18.122 Million. In compliance of EDF Policy, a Joint account of TDAP & PTA had been created and now in operational in National Bank of Pakistan (NBP), FTC Branch, Karachi for transaction. I hope, TDAP will issue Cheque for Rs.18.122 Million soon on account of approved 3-International Fairs.

• Request for 75% subsidy from EDF for International Lab Testing for Leather For the facilitation of PTA's member exporters, PTA had submitted its proposal to EDF for grant of 75% subsidy for International Lab Testing of Finished Leather on 17th October'2020, accordingly, the proposal was considered in the 19th Meeting of the

Finance Committee of the Board of Administrator of EDF held on 18.03.2021. The Finance Committee of EDF had approved Rs.60 Million as 75% on Lab tests charges for leather exporters effective from 18th March'2021, till complete utilization of funds, with TDAP's collaboration.

For the purpose, a Joint account of TDAP & PTA had been activated in July'2022 in National Bank of Pakistan (NBP), FTC Branch, Karachi for issuance of Cheque for Rs.60 Million by TDAP on account of Int'l Lab Testing of Leather.

ROLE OF TRADE DEVELOPMENT AUTHORITY OF PAKISTAN (TDAP)

I would like to appreciate the support and cooperation of TDAP for exploration country's export specially for Leather Sector.

PTA organized following International Fairs @25% subsidy on stand cost as approved by EDF for organizing Pakistan Pavilion by PTA for its interested member participants in my tenure from October'2021.



SBP – STATE BANK OF PAKISTAN

During the fiscal year, PTA faced various SBP related issues and approached SBP for its resolution. We appreciate SBP for timely intervention in the following matters for favourable consideration :

- 1. Request to ease procedure of SBP Online Portal for getting prior approval and due remittance of Space Rent and Construction Charges of stands as booked for PTA's member's participation in International Fairs at various destinations as already approved by EDF, Ministry of Commerce and Trade Development Authority of Pakistan to avoid cancellation of space and foreign exchange for the country to be earned in result of participation in Int'l Fairs.
- 2. Request to allow import and to ease the procedure for getting approval from SBP for import of Tanning Machines and spare parts under Chapter 84 & 85 for producing value added finished leather and leather products to avoid production loses.
- 3. To extend period of repatriation of export proceed amount from 120 days to 180 days.
- 4. To resolve exporters problem for export to Russia and releasing the repatriation of money from Russia against LC's advance payment.

GRANT OF EXEMPTION FROM SALES TAX UNDER SIXTH SCHEDULE OF SALES TAX ACT 1990

Due to continued follow-up of PTA and arranged meetings with the Ministry of Finance and FBR, the Government re-included Raw Hides & Skins in Finance Bill 2022 and in the 6th Schedule of the Sales Tax Act, 1990 under Table # 2 of Local Supplies at Serial # 52 amended on 30th June'2022 and exempted local supplies of raw hides and skins from Sales Tax for the facilitation of leather sector.

GRANT CONCESSIONARY TARIFF RATE ON SUPPLY OF ELECTRICITY & GAS TO 5-ZERO-RATED SECTORS FY 2022-23

Economic Coordination Committee (ECC) of the Cabinet has decided to grant concession Tariff Rate on Supply of Electricity & Gas to five Export Oriented Sectors including Leather Sector for the year 2022-23 effective from August'2022 with proposed rates of Electricity at US cents 9 per KWH and RLNG at US\$ 9 per MMBTU.

RELEASE OF PENDING SUBSIDY BY TDAP

Due to PTA's persistent efforts, TDAP released pending subsidy of Lineapelle Fair-2020 and Lineapelle Fair-September-2021-Milan, Italy in April'2022 and the subsidy cheques received from TDAP have been disbursed amongst the member participants concerned which is encouraging for making their regular participation in International Fairs enthusiastically.





SALIENT FEATURES OF THE FEDERAL BUDGET 2022-23

The Federal Budget 2022-23 announced by Mr. Miftah Ismail, Finance Minister on June 11, 2022. I would like to present hereunder Salient Features of the Budget 2022-23 :

INDUSTRIAL RELIEF MEASURES:

- 01. Reduction in CD and ACD on 10 tariff lines pertaining to direct and reactive dyes.
- 02. To incentivize footwear industry, customs duties have been reduced on different categories of other woven fabrics and artificial flowers / foliage of other materials.
- 03. To encourage export oriented industry, CD and ACD have been exempted on import of Guts, bladders and stomachs of animals etc.

RELIEF MEASURES - SALES TAX ACT 1990

- 01. Local supply of raw hides & skins exempted from Sales Tax.
- 02. The condition of CNIC/NTN in case of supply to unregistered person have been removed.
- 03. Temporary imports have been exempted from the levy of the sales tax.
- 04. Import by EPZ has been exempted from sales tax.

REVENUE MEASURES

- 01. The scope of further tax has been enhanced to include non-active taxpayers as well.
- 02. Regime of other then Tier-1 retailer has been streamlined.

REVENUE MEASURES – INCOME TAX ORDINANCE 2001

- 01. Increase in tax rate for banks for tax year 2023 onwards from effective 39% to 45%.
- 02. Increase in rate from 1% to 2% on sale and purchase of property for filers.
- 03. Increase in rate from 100 percent to 250 percent in case of purchase of property by persons who are not active taxpayers.
- 04. Withdrawal of Income Tax (Amendment) Ordinance, 2022.

RELIEF MEASURES

- 01. Adjustment of tax collected on all materials at import stage for industrial undertaking for own use.
- 02. Relief on taxation for salaried and business individuals by increasing threshold for taxation.

- 03. Exemption from tax on income of certain non-profit entities.
- 04. Withdrawal of withholding tax on rent of machinery.
- 05. Exemption from advance taxes to exempt entities.

STREAMLINING MEASURES

- 01. Requirement for adoption of digital mode of payment for companies.
- 02. Clarification regarding exempt income of partners if income of AOP is exempt.
- 03. Enhancement of restriction for passing of order in from 120 to 180 days.

DOCUMENTATION OF ECONOMY MEASURES

- 01. Increase in scope of tax on payments to non-residents and enhancement of rate from 5% to 10% on offshore digital services Increase in scope of tax on payments to non-residents and enhancement of rate from 5% to 10% on offshore digital services.
- 02. Introduction of advance adjustable tax on credit/debit card payments.
- 03. Sharing of information between NADRA and FBR for tax base broadening.

- 02. Release of Pending subsidy for Lineapelle Fair, Sept'2021 at Milan, Italy to 12 Participants IRRESPECTIVELY as condition for 2 times & 5 years has already been removed by TDAP, Karachi.
- 03. To finalise the internal procedure at TDAP for the release of 75% subsidy for International Lab Testing of "Finished Leather" by PTA's members exporters which was w.e.f 18th March, 2021 as the fund for Rs.60 Million has already been approved by EDF in its meeting held on 18.06.2021.
- 04. To recommend PTA's request for the replacement of Int'l Fairs already made to EDF, Islamabad and copied to TDAP.
- 05. PTA's delegtion led by me held Meeting with the then Finance Minister, Mr.Shaukat Tarin on 12th February'2022 at Governor House, Karachi to discuss following core issues of Leather Sector Industry. PTA's delegation comprising Mr. Aziz Ahmed, Vice Chairman, PTA (Central), Mr. Ejaz Ahmed Sheikh, Mr. Hamid Arshad Zahur, Sh. Afzal Hussain, Mr. Aga Shafi alongwith Mr.Fawad Ijaz Khan, Petron-in-Chief, PLGMEA and Mr. Irfan Iqbal.

ISSUES OF LEATHER INDUSTRY :

- 1. To remove 5% Withholding Sales Tax on purchase of Raw Hides & Skins for which a request has also been submitted to the Finance Minister during the meeting and he assured for removal of anomaly as the Raw Hides & Skins are included in the finance bill as Agriculture produced item and exempted from duty.
- 2. To issue SRO for inclusion of Finished Leather in the New DLTL scheme as it was approved in STPF 2020-2025 announced recently. He assured for early issuance of SRO in coordination with the MoC.
- 3. To extend period of repatriation of export proceed amount from 120 days to 180 Days. He endorsed PTA's proposal and accordingly necessary Notification has been issued by SBP on 16th February'2022 for extension period of 180 days instead of 120 days.

- 4. Strongly requested during the meeting to adopt the procedure for the refund of Income Tax through Automated System in line with other refund already made for Sales Tax & Duty drawback for facilitation, which has also been ensured for the implementation in coordination with FBR.
- 5. Request for removal of Quarantine Certificate on import of Raw materials into Pakistan, which has already been removed under Part-III of the Import Policy Order 2020 issued on 25.09.2020 while the implementation did not maintain in PRAL system at Custom House for incorporation resultantly the due incentive has not been entertained by our members.

The Chairman, FBR was also apprised about the main four (4) issues of finished leather exporters i.e. 1) Request for immediate removal of anomaly for the imposition of 5% Withholding Sales Tax on purchase of Raw Hides & Skins 2) Request to issue directives to IOCO, Karachi for adopting the practical formula on "Weighted Average" instead of "Arithmetic formula" for determination of FOB price for Finished Leather for the revision of Duty Drawback Rates 3) Request for removal of 100% Cash Margin imposition on import of tanning industry under HS Code # 3204.1300 / 3402.1190 and 4) Request to process Income Tax Refund under Section 170 through Automated System like Sales Tax refund.

The Chairman, FBR has assured PTA delegation to resolve the issues of the export-oriented Leather sector on priority.

13. PTA Delegation Meeting with the Federal Minister for Commerce on 13.07.2022 at Camp Office in Karachi

A meeting of PTA delegation led by me accompanied by Mr. Ejaz Ahmed Sheikh, Mr.Shafique Ahmed, Mr. M. Saleem Ahmed and Mr. Muhammad Ali, SG/PTA held with Syed Naveed Qamar, Federal Minister for Commerce on 13th July'2022 at MOC's Camp Office in Karachi to discuss following core issues of leather industry for resolution :

- 1. To Remove Quarantine Certification condition on import of Raw Hides & Skins into Pakistan for re-export in finished leather form to world for earning foreign exchange for the country while the Health Certificate already issued by the country of destination concerned, for which the Minister has assured PTA for taken-up this irrational condition of quarantine certificate with the Ministry of National Food Security & Research for removal which was imposed un-necessary.
- 2. To Release 2nd Tranche for Rs.113.930 Million from EDF as 80% Subsidy on Stand Cost for participation of PTA's member exporters in Int'l Leather Fairs which was already submitted to EDF for the allocation in continuation of earlier grant approved by EDF in its meeting on 16.06.2021 and 17.02.2022 respectively. The Minister for Commerce assured for consideration of PTA's proposals for allocation of fund for 2nd Tranche in the next EDF Board Meeting.
- 3. To approve subsidy Rs.900 Million from EDF for establishment of Effluent Treatment Plants in individual Tanneries in compliance with WTO rules for enrolment of Leather stakeholders in LWG by the end to 2022 to enable the exporters to sell their Finished Leather to World's top brands for which a proposal was submitted to EDF through its Web Portal as desired for early redressal. The Commerce Minister assured for all his possible cooperation for the exporters of Leather Industry in this regard.
- 4. To coordinate with the Ministry of Finance for early issuance of SRO for DLTL with inclusion of value-added Finished Leather in New DLTL Scheme FY 2020-2025 with all related HS Codes of Finished Leather at 4% DLTL rates in supersession of SRO 711(I)/2018 dated 08.06.2018 issued without inclusion of Finished Leather for facilitation of the exporters of Finished Leather too like other stakeholders of Leather Industry.
- 5. To induct Chairman, PTA in EDF Board to represent value added tanning- industry in the EDF Board's meetings like other stakeholders of the Leather Sector. The Commerce Minister assured for the desired induction of Chairman, PTA in EDF Board.

Mr. Agha Saiddain presented two core issues of PTA's members during the meeting 1) determination of real method of Weighted average for ascertaining the actual Duty Drawback rates for Finished Leather for which it was discussed/deliberated with convincing notes given by Mr. Agha Saiddain as to be real & effective method to be adopted by IOCO/FBR only with "Weighted Average" instead of Arithmetic average and accordingly in conclusion the Government's side specially FBR was seems convinced finally and assured PTA's representative for adequate resolution for proceeding with harmony in this regard 2) removal

of 5% withholding tax on Raw Hides & Skins with retrospective effect from July'21 to June'22, accordingly the Chairman FBR, Mr. Asim Ahmed has firmly assured during the meeting for early resolution of the issue for facilitation to PTA's member exporters.

PENDING ISSUES :

I would like to summarize hereunder some core issues of the Leather Industry which need constant follow-up during the next year term 2022-23 too for the facilitation of PTA's members:

- Requested Ministry of Commerce for early issuance of Notification for DLTL on Finished Leather @4% FY 2020-2025.
- Requested Ministry of Commerce for withdrawal of irrational condition of Health Quarantine Certificate on import of Raw Hides & Skins for Tanning Industry, as the import of raw materials is already supported with Quarantine Certificate issued by the Ministry of destinations concerned.
- Requested IOCO for revision of DDB rates for Finished Leather of Cow/Buff Hides, Goat/Sheep Skins as per consensus with PTA's proposed revised Working Sheets w.e.f. July'2022 and issuance of SRO accordingly.
- Requested EDF and TDAP to increase subsidy from 25% to 80% on Int'l Leather Fairs allocated to PTA.
- Requested TDAP for issuance of Cheques, for already approved amount by EDF for PTA, from Joint Account of TDAP/PTA of Rs.60 Million for 75% subsidy for Lab Testing of Finished Leather and Rs.18 Million for organizing of 3-International Leather Fairs.

- 02. APLF- 30 March -1 April 2022 at Dubai UAE (already organized)
- 03. Shoes & leather, 16-18th Nov., 2022 at Ho Chi Minh City, Vietnam (organizing by PTA)







He also joined PTA delegation and participating in the meeting held with Syed Naveed Qamar, Federal Minister for Commerce on 13th July'2022 at Camp Office of MoC in Karachi. During the meeting he strongly stressed the Commerce Minister for removal of irrational condition of Quarantine Certificate imposed un-necessary on the import of Raw Hides & Skins, Pickled and Wetblue Leather by tanning industry into Pakistan for re-export purpose in finished leather for earning foreign exchange for the country while the Health Certificate already issued by the country of destination concerned.

After due deliberation, the Commerce Minister apprised PTA successful to Ministry of National Food Security & Research and he assured his

delegation that the issue related to Ministry of National Food Security & Research and he assured his cooperation for taking-up the issue with the Ministry concerned for resolution.

Due to his continued efforts, following incentives announced by the Government in the Budget FY 2022-23 for facilitation of members of tanning industry :

- 01. Reduction in CD and ACD on 10 tariff lines pertaining to direct and reactive dyes.
- 02. Local supply of raw hides & skins exempted from Sales Tax.

The critical matter as being faced by PTA's members exporters was also taken-up with the SBP and requested to withdraw its condition for prior approval of import of Spare parts/machinery for Leather/Footwear Industry under Chapter 84 & 85 to help releasing of import shipment without delay and save them from heavy demurrage at ports and further cancellation of export order.

He also assessed and verified the prices of Raw Hides & Skins and Chemicals imported by our members concerned from various countries during the year as and when they required to get certified from the Association for their onward submission to Customs to help releasing their import consignments without delay.

- 2) Requested to issue directives to IOCO, Karachi for adopting the practical formula on "Weighted Average" instead of "Arithmetic formula" for determination of FOB for upward revision of Duty Drawback Rates for Finished Leather of Cow/Buffalo Hides & Goat/Sheep Skins w.e.f. July'2022



HAS PANDEMIC ENDED GLOBALIZATION FOR The Leather Industry By MR. AGHA SAIDDAIN

The increase in world population and growing interdependence pushed the world towards globalization in the areas of Trade, Technology and flow of investment. But in recent years ecological globalization i.e. issues relating to population, environment, access to food, reduction in biodiversity gained more importance than other factors. The leather industry witnessed these factors in shape of animal welfare, traceability, ZDHC environmental compliances which are now mandatory to work with any of the leading brands. To monitor these factors LWG emerged as important body to certify the

leather producers who are compliant of these requirements to qualify as suppliers of big brands. The consumers at global level become conscious of animal welfare, environment, and CRS through campaigns of various NGOs. Covid-19 pandemic is not an only factor which has affected the leather industry but there are many other issues such as higher freight charges both Air and Sea, non availability of chemicals etc. The prices of all chemicals have jumped at global level. The reason for this unusual price increase which is against basic principles of economics is said to be due to non availability of basic chemicals and work force.

The idea of free trade was initiated in 1990 which later on emerged as globalization. The global trade which was recorded as 39% in 1991 increased to 61% during 2008. But after financial crisis of 2008 the globalization started shrinking. Anti-globalization policies were big blow to the globalization. The slogan "AMERICA FIRST" by President Trump and Brexit further retarded globalization.

The world was already moving towards de-globalization and Covid-19 Pandemic further halted it. Though it is an established principle of social psychology that any external

threat or fear increases cohesion among all nations and it was witnessed when Pakistan offered medical assistance through various NGOs when pandemic was on its peals in India. But it has not proved true at global level because it halted movement of people, goods, services, and capital all over the world. The supply chain of leather was badly affected due to this pandemic. The leather industry which had shifted from developed world to developing nations and hides and skins being produced in Australia, U.S.A, U.K, Europe, Brazil, and South Africa, were exported to India, Pakistan, China, Turkey, and Bangladesh, and other developing Countries to convert these into finished leather and value added products like footwear, bags, garments, and auto leather.

Covid Pandemic coupled with higher sea freight have badly affected supply chain of tanneries in developing countries and many tanneries based on imported hides/skins have closed their operations. This has also affected hides/skins suppliers in developed countries as sea freight jumped many fold which made export of hides/skins so costly which is beyond the reach of consumers of hides and skins in developing countries. The leather industry is interdependent and main source of raw skins & hides are countries where environmental compliance is costly and labour charges are high. Leather industry being labour intensive is feasible only in underdeveloped countries where cheap labour is available and environments quality standards are not so high. The developed nations like Europe and U.S.A are producing chemical and machinery for this industry and these producers are dependent on tanneries in underdeveloped world.

We can say globalization had mixed behaviors during pandemic. We observed globalization increased for companies involved in on line business like Amazon, Alibaba, and globalization sharply declined as for as travel industry and truism is concerned which reduced by almost 90%. For leather industry we can say pandemic added difficulties in the areas of supply chain, exhibitions, travelling, and higher input cost and globalization has almost finished. Even though it has touched the bottom but we must stay together for survival of this ancient industry.

EXPORTS PERFORMANCE OF LEATHER & LEATHER PRODUCTS FROM PAKISTAN DURING JULY-JUNE 2021-2022 vis-à-vis 2020-21

The Leather Sector of Pakistan is growing steadily and registered remarkable exports during the current fiscal year July-June 2021-22 at US\$ 953.707 Million as compared to the same period of last year at US\$ 832.824 Million showing increase of 14.51% despite various economic obstacles especially COVID-19 repercussions. The Leather Sector optimistic to achieve US\$ 1 Billion Mark in its export in near future, Insha-Allah.

The Finished Leather exports registered growth by 28.50% during July-June 2021-22 and remained at US\$ 208.092 million compared to US\$ 161.940 million during the same period of last year.

During the year 2021-22 about 16.078 million Square Meter of Finished Leather were exported to potential International markets and registered increase of 33.68% in Quantity as compared to the same period of the corresponding year of 2020-21.





NATIONAL INSTITUTE OF LEATHER TECHNOLOGY (NILT)



The prestigious National Institute of Leather Technology (NILT) basically established in 1998 by PTA in financial collaboration of TDAP is now being managed under the independent Board of Governors. This institute housed in a splendid building in Korangi Industrial Area imparts technical and scientific training to the students as well as to the in-service technicians to enable them to serve the tanning, leather sector industry proficiently. Most of the members on the Board of Governors of NILT are from Pakistan Tanners Association who have been contributing their tangible share to make it a state of the art institute

aimed at upgrading qualitatively all the leather sectors to be competitive in the world market.

The National Institute of Leather Technology (NILT) is having a qualified faculty team to keep leather industry abreast with modern technology and practices as well as to provide a platform for human resource development. NILT was set up as an institute on national level of an international standard. This institute is planning to upgrade its status which needs full financial support from the Government.

NILT is affiliated and recognized by Sindh Board of Technical Education and Internationally by University of Northampton U.K. Presently Academic courses of DAE (3 Years), Executive Diploma (1 Year) and BBSYDP course (6 Months) are continued at the institution.

COMBINED EFFLUENT TREATMENT PLANT (CETP)

The Combined Effluent Treatment Plant (CETP) for Korangi Tannery Cluster in Sector 6-C, Korangi Industrial Area, Karachi was set up with the cooperation of Ministry of Commerce, Government of Pakistan, Dutch Government, Government of Sindh, City District Government and PTA (Southern Zone).

Recently on the request of PTA (S.Z) Environmental Society, Export Development Fund, Ministry of Commerce approved funds for up-grading the CETP to move on a new technology i.e. Activated Sludge, as well as improve the Conveyance System by installing pipes to bring waste water from the tanneries to the Plant. Work is in progress and hopefully the up-grading will completing by end of next year.

The Plant operation and etc. work is managed by 11 Members elected Managing Committee

The main objective of the CETP running under its President Mr. Gulzar Firoz is to benefit tanning community at Korangi Cluster, general public, marine life as well as to meet National Environmental Quality Standards (NEQS) which is mandatory and to meet international compliances.

CENTRAL MANAGING COMMITTEE MEETINGS

Elected representatives of PTA from Northern Zone made active representation in the Central Managing Committee of PTA by attending the meetings at Karachi/Lahore held simultaneously at Lahore and Karachi office through Video Conference System. In this connection, PTA Northern Zone remained co-host for all sessions of Central Managing Committee meetings.

LIAISON WITH WITH CORPORATE TAX OFFICE (CTO) LAHORE INLAND REVENUE

Every year Association office keeps close liaison with the office of Chief Commissioner CTO, Inland Revenue Lahore. Leading towards the end of last financial year 2021-22, members of PTA-Northern Zone received notices from Inland Revenue Department Corporate Tax office regarding non-payment of 5% withholding Sales tax on purchases. The department also raided few units and scenes of tax payer harassment were observed. All the stern actions by the department created panic amongst the industry.

Members of Northern Zone joined efforts for approaching the apex level in Ministry of Finance. I'm grateful to Ch. Ahmed Zulfiqar Hayat who extended his support in this regard and took Sialkot Chamber of Commerce onboard and senior political leadership. It was due to Ch. Zulfiqar Hayat and his thorough efforts so that Finance Bill 2022 approved with Raw Hides & Skins included in Schedule-VI under Table-II of Local supplies at \$\mathbf{S}\# 52 Pg:210 of the Bill.

Later, a high level delegation from Central office of PTA could meet Federal Minister for Finance Mr. Miftah Ismaeel in Islamabad wherein Khawaja Asif, Mr. Asim Ahmed, Chairman, FBR, Ms. Suraiya Butt, Member Policy, FBR, Secretary Finance and other high officials were also present. The delegation visited Minister of Finance for settling the matter of 5% withholding tax with retrospective effect ie. from July'21 to June'22. This had been a vital issue for which along with Ch. Zulfiqar Hayat sb, I'm also

grateful to Mr. Agha Saiddain for joining the PTA delegation and explaining the matter in detail. The delegation presented key evidences during the meeting to convince the authorities. Accordingly, Chairman FBR, Mr. Asim Ahmed agreed and assured firmly to resolve the issue to the satisfaction of industry.

We are also obliged to the Chairman PTA Central office for taking up the matter and keeping close follow up with Ministry of Finance and FBR Islamabad.

PENDING CLAIMS OF CUSTOMS DUTY DRAWBACK

This year, the introduction of Pakistan Single Window – PSW system brought new features for online processing of export and duty drawback claims.

At the startup of PSW, members came up with their complaints that were expected with the introduction of new system. However, with the passage of time, PTA-NZ also kept facilitating its members by amicably handling and forwarding their complaints to respective authorities dealing with PSW System.

No major setback faced and/or issue is reported from members of PTA-Northern Zone this year.

LIAISON WITH TRADE DEVELOPMENT AUTHORITY OF PAKISTAN, LAHORE OFFICE

PTA-NZ has been maintaining close liaison with Trade Development Authority of Pakistan, Lahore Office to resolve our members'/ exporters' day-to-day problems concerning exports. This cooperation remained continue in the regime and proper facilitation from TDAP office was arranged for members of PTA-Northern Zone.

LIAISON WITH ZONAL OFFICE OF FEDERATION OF PAKISTAN CHAMBERS OF COMMERCE AND INDUSTRY (FPCCI)

At this forum, our members used to representand attend meetings as and when called pertaining to different matters of interest and benefit for the sector. The presence of PTA-NZ member at the platform of FPCCI is very important and it needs to be maintained in future.

WWF-PAKISTAN: A MEETING WITH TEXTILE & LEATHER ASSOCIATIONS OF PAKISTAN

WWF-Pakistan office arranged a meeting of key stakeholders from Leather and Textiles Sector on sector-specific environmental quality standards. Secretary PTA-NZ attended the session, as directed by the authorities. Meeting was held on 9th December 2021.

A representative from NAMA Project Islamabad also present during the meeting. He informed the participants regarding upcoming support from Government to fund the green initiatives by the industry.

In the context of sector-specific environmental parameters, Secretary PTA-NZ informed that USAID has already conducted a comprehensive study report and submitted its report which is pending with Environment Protection Department, Government of Punjab for consideration and devising action plan on its recommendations. He promised to share the report contents with WWF-Pakistan.

WWF-PAKISTAN: ROUNDTABLE DIALOGUE ON IMPROVING GSP+ COMPLIANCE

Pakistan is the major recipient of the GSP + scheme for the last seven years. Under this status – set to expire on Dec 31, 2023 – there is zero percent duty on several products. Under the current GSP + system, the EU

continues monitoring the progress made by the beneficiary countries towards the implementation of 27 international conventions. Therefore, International Labour and Environmental Standards Application in Pakistan's SMEs (ILES) – a WWF Pakistan initiative, organized a roundtable discussion to explore areas for improving GSP+ compliance in Pakistan and extending it beyond 2023.

On the direction of Mr. Muhammad Musaddiq, Convener Environmental Subcommittee, Secretary PTA-NZ participated in the subject roundtable dialogue held on Monday 18-April-2022.

Participants from APTMA, PRGMEA, PHMA, PFMA and textile industries were present during the session.

Mr. Sohail Naqvi, Senior Manager ILES briefed the objectives of roundtable and informed that GSP+ scheme requires country compliance on 27 international conventions signed by Government of Pakistan.

Further extension of GSP + scheme for Pakistan after 31 December 2023 would require country compliance status on 32 (additional six) conventions/protocols signed.

WWF Pakistan and ILES Project wants to assist the textile and leather exporting industry, being major exporter to EU, to start reporting on environmental parameters that would contribute country's performance to carry on GSP+.

In this respect, ILES Project has developed a dashboard that would assist the industry to report and update their environmental performances. ILES/WWF Pakistan has planned to involve trade associations to file/report collective industrial data on the dash board so developed.

If associations agree on the proposed arrangement of filing and reporting collective data on environmental performance of the industry, then another session will be held after Eid in which identified representatives from each association will receive orientation on use of dashboard so developed by WWF Pakistan for reporting.

Representatives from textile association and PRGMEA confirmed that their Associations have almost all the desired data available with them and they are ready to share with Government/WWF Pakistan in a collective mode.

Secretary PTA-NZ inquired about international practices for sharing of similar reports/data in India and Bangladesh who are also enjoying GSP status and are major EU exporters.

Mr. Naqvi replied that Bangladesh is exporting EU under (Everything but Arms) EBA scheme that will soon come to an end and Bangladesh will enter in GSP+ scheme. For India, WWF/ILES Project will check the status from respective departments.

With a consensus note that all exporting associations will participate in the orientation session after Eid to learn use of Dashboard developed for reporting of industry environmental performance, meeting was concluded.

PILOT/DEMONSTRATION RESOURCE EFFICIENCY & CLEANER PRODUCTION INVESTMENTS IN KEY INDUSTRIAL SECTORS HELD ON AUGUST 18, 2022 AT LAHORE CHAMBER OF COMMERCE & INDUSTRY

Government of the Punjab along with World Bank has developed a broad program "Punjab Green Development Program" to address environmental issues and promote green development at Punjab on short, medium and long term basis.

In this context, Punjab Small Industries Corporation (PSIC) is implementing an Annual Development Program funded scheme titled "Pilot/Demonstration Resource Efficiency & Cleaner Production Investments in Key Industrial Sectors".

Five major sectors included in this scheme for providing financial support are: Leather, Stone crushers, Rice husking mills, Steel furnaces, Re-rolling units. In this regard, Program Delivery Unit of Punjab Small Industries Corporation arranged a meeting with relevant stakeholders and industrial owners of the above mentioned prioritized sectors on August 18, 2022 at Lahore Chamber of Commerce & Industry.






