# **3 YEARS PLAN OF ACTIVITIES (2019-2022)** Under Rule 23(1) of the TOR-2013 **PAKISTAN TANNERS ASSOCIATION** (Approved by the Executive Committee of PTA)

**Pakistan Tanners Association** represents the highly value added Tanning Industry which is the mother Industry for the whole Leather sector of Pakistan and termed 2<sup>nd</sup> largest industry after Textile. This prestigious trade body is locally as well as internationally recognized foreign exchange earning conglomerate of leather & leather products industrial sectors duly licenced by the Ministry of Commerce under Trade Organizations Rules, 2013, registered with the Security and Exchange Commission of Pakistan (SECP) as well as affiliated with the Federation of Pakistan Chambers of Commerce and Industry (FPCCI).

**The Three years Plan of Activities** of Pakistan Tanners Association as required under Rule 23(I) of the Trade Organizations Rules, 2013, approved by the Central Executive Committee, PTA is highlighted hereunder:-

# 1. KEY ISSUES OF LEATHER INDUSTRY TO BE TAKEN UP WITH THE COMPETENT AUTHORITIES CONCERNED :

The Association, during the **next three years 2019-20, 2020-21 & 2021-22,** will toil hard to get the thorny issues of leather industry resolved expeditiously by using all possible fora. In this connection besides addressing necessary letters with details of PTA members' grievances/problems to the competent authorities concerned even at the highest level in Islamabad or any city as convenient to them will release press statements through leading newspapers, hold press conferences and meetings with authorities concerned.

The Executive Committee of PTA has chalked out year-wise comprehensive programmes to hold meetings with the Advisor to Prime Minister on Commerce, Advisor to PM on Finance, as well as Chairman, Federal Board of Revenue, Secretary, TDAP, Governor, SBP, concerned Collectors of Customs, Income Tax & Sales Tax to discuss core issues, problems, proposals/suggestions for providing maximum relief and assuagement to PTA member importers & exporters and to ventilate their genuine grievances as well as to lodge protest against un-business friendly policies and decisions detrimental to the industry and harmful to the leather exporters.

The Association under its Chairman guidance will keep on pursuing all the pending as well as growing core issues of leather industry by taking up the same with the Government authorities concerned at all the relevant fora for redressal as expeditious as possible. In this context, besides making regular correspondence with the concerned Ministries & Departments concerned highlighting details of the member exporters' grievances/snags impeding their business activities and enervating flow of exports, appointments would be sought from the relevant authorities for holding face to face meetings to convince them on justified arguments, facts and figures to get the industry's problems resolved and genuine/rational proposals entertained to save the significant tanning industry from collapse which is already sagging due to various reasons.

The leather industry have long and short term targets/proposals, some of which are highlighted below which will be taken-up on priority with the higher competent authorities concerned for expeditious redressal :

# i) Amendment in SRO 578(I)/2016 Dated 01-07-2016

Request has been made to the Ministry of Commerce as well as continuously follow-up will required for the next year till its resolution for amendments in a SRO 578(I)/2016 for grant of Government Subsidy ('o' rated Custom Duty) on Import of 24 Tanning Machines as detailed has already been provided to MoC by PTA which will help us to upgrade and modernize our tanneries to boost our exports.

PTA for the facilitation to its members has taken up the matter with the FBR & other concerned Govt., departments for the exemption of 10% Sales Tax and 7% IB (Indemnity Bond), which is also causing severe hardships to stuck the huge amount in refund of Sales Tax with the cumbersome procedure laid down in the Sales Tax collect orate and certainly rendering our members unable financially for the execution of export activities in time, which is resulted in losing precious foreign exchange for the country in general and losing the valued potential customers in particular.

PTA is persistently tying to remove these bottlenecks for its members for the import of Tanning Machineries without custom duty & sales Tax, which is the dire need of the industry for the up-gradation to improve their quality production with innovation upto the international standard and to meet the foreign buyers/customers demand/requirement.

# ii) Amendment in SRO 630(1) 2018 Dated 24-05-2018

Will pursue PTA's request for removal of ACD 2% on Import of Raw and Wet Blue of Cow/Buffalo during the next year till its resolution as was imposed through the above SRO 630.

# iii) <u>Removal of Quarantine Certificate under SRO 1067(1) 2017 Dated Oct 20, 2017</u>

The restriction for the Quarantine was originally imposed inadvertently with the general food items as the Leather is the Agriculture Produced Products, which was later on realized by the competent authority on approach made by PTA and assured to remove this Quarantine requirement for Leather, which is the basic raw back materials for the Leather Industry for necessary value addition for re-export purpose.

Besides, PTA has also clarified that the **Wet Blue hides & Skins/Raw Materials** is imported from various destinations of the world with **Quarantine Certificate** at the Destination, which is the pre-requisition for the import into Pakistan, as such, duplication for the Quarantine requirement here in Pakistan is **completely unnecessary.** 

PTA will follow-up in the next year too its request for removal of Quarantine Certificate under the above SRO as already sent to MOC with the clarification that the Supplier already issue Quarantine Certificates of shipments of Raw Skins as a regular practice and no need to submit it again at domestic/local level.

# iv) LWG Certification

PTA's proposal as already sent to Ministry of Commerce for allowing subsidy on Individual Treatment Plants to facilitate in time LWG (Leather Working Group) Certification **which would be mandatory after 2020** needed to keep continue follow-up in next year for Government consideration and implementation. The export of Leather and Articles made of Leather (Apparels, Footwear, Gloves, and Leather Goods) would not be allowed to any country unless leather is from LWG Certified Tannery.

PTA has also submitted the proposal for the financial assistance to be extended by MOC from EDF for its interested member exporters in establishing the Individual Treatment Plants at Punjab and Sindh, which is appended below :-

- approximate amount : Rs.400 to Rs.500 Million
- approximate No of Tanneries : 12-15 Nos for individual treatment plants.

It is also added here that the allocation of fund for the establishment of Individual Treatment Plants, which is fundamental now is one of the specific demands of PTA for its members' facilitation with convenience for meeting the international requirement for Green environment without any hazards.

PTA will also kept continue its follow-up on its proposal as already sent to MoC to allow Matching Grant for Setting Up of Individual Treatment Plants in Trade Policy 2018-21 as allowed under STPF – 2009-12. The major cost of LWG would be in setting up Treatment Plants in Individual Tanneries Contributing 80% of leather exports.

# v) <u>Subsidy on Lab Testing</u>

The incentive for extending 75% subsidy on Lab Texting was allowed earlier but discontinued for a long time, while the necessity for the continuation for such pivotal incentive is utmost imperative as such PTA has demanded persistently for its members to continue to allow such incentive for 75% subsidy on lab Testing for Leather, which is the basic requirement of Foreign buyers/Customers before purchasing the finished leather from Pakistan.

PTA will taking-up with Ministry of Commerce its demand to allow 75% subsidy on Int'l lab testing for Leather under the forthcoming STPF 2018-23.

# vi) Subsidy on International Fairs and Exhibitions

It is the universal tested tool for marketing & promotion for participation in Int'l Fairs & Forms Trade Delegation to explore new best avenues for the exploration and PTA in financial collaboration with TDAP is on same track for the last several years consecutively and organizing "National Pavilion" at various destinations of the world in well renowned leather fairs for participation of its members.

In this context, PTA has submitted its concrete proposals to TDAP & MOC for the resolution to the desired extent for the supreme motive to provide level playing field at par with others particularly neighbor competing countries, who are penetrating more effective in the international leather market for capturing :-

- To increase the subsidy percentage from 40% to atleast 75% on stand cost for participation.
- To remove irrational condition of 5 years in International Fairs, which is really detrimental to the promote of exports.
- To remove 2 times participation in a year.
- To allow necessary subsidy percentage on Air freight of sample shipment meant for display at destinations at the respective booths of Pakistan Pavilion, which is element for our members participation.

PTA is also considering to organize "**Single Country**" exhibition at the selected destination(s) of the world, which is the exceptional activity exclusively for Pakistan for B2B meetings, B2C & other productive to be conducive for the conclusion of desired objectives for the promotion of exports.

PTA will pursue its demand to increase government subsidy from 40% to 75% from Export Development Fund for participation in Int'l Fairs and Exhibitions.

#### vii) To Include Value Added Finished / Dyed Leather in DLTL Order 2018-21

It was really unfortunate for Tanning Industry/Leather Sector of Pakistan to exclude Finished Leather unilaterally by the Government for the New DLTL Scheme for the year 2018-21 as announced thru SRO # 711, while the finished leather was already included in the earlier DLTL scheme for the year 2016-17 & 2017-18 for which a detailed meetings were already held with the Ministry of Commerce specially Advisor to PM On Commerce & Textile, Mr. Abdul Razzak Dawood and accordingly it was assured to PTA for the inclusion of Dyed/Finished Leather with 5 H.S. codes in the new DLTL scheme at SRO # 711 with certain revision, which is still awaited by the Industry. **PTA is striving very hard to make it ensure for the inclusion for the betterment of the Industry in general and to facilitate its member exporters in particular so that the real benefit could also be continued to be extended to Leather Exporters too being core value added product of the country for yielding sizeable foreign exchange as per aspiration of the Government.**

PTA will follow-up with Ministry of Commerce for its genuine demand for inclusion of High quality valued added Dyed/Finished Leather for inclusion in DLTL Order 2018-21 under DLTL Scheme 2018-21 which was left to be included due to misconception. Presently Finished Leather which is producing in Pakistan is being supplied to big brands like **GEOX**, **HARLY DAVIDSON**, **ALPINESTARS**, **BALLY**, **IKEA**, **COACH**, **GUCCI**, **CK**, **CLARKS**, **ARMANI** and many other famous brands of the world. Unfortunately, the DLTL on finished leather was totally withdrawn and H.S. Codes of Dyed and Finished Leather were omitted in SRO 711(1)/2018 dated 8<sup>th</sup> June'2018 for DLTL (Non-Textile Order, 2018) for the period from 1<sup>st</sup> July'2018 till the 30<sup>th</sup> June'2021 for 3-years this was injustice to leather sector.

As per PTA persistent demand, it will again pursue with Ministry of Commerce and Ministry of Finance for inclusion of Dyed Leather/Dyed Leather under HS Codes **4107.1200 / 4107.9200 / 4107.9100 / 4112.0000 / 4113.1000 / 4113.9000** in the SRO 711(I)/2018 for DLTL Order 2018-21.

# viii) FTA with – Pakistan-Japan and Pakistan-South Korea

PTA will take-up with Ministry of Commerce again for its proposal of inclusion of Items of Finished Leather in FTA with Pakistan Japan & Pakistan-South Korea with zero-rated import into these Countries as the same facility as allowed to Bangladesh so that Pakistani Leather exporters can get level playing field in Japanese and South Korean markets. A comparative table is illustrated below for duty on export of Finished Leather from Pakistan into Japan & South Korea as comparison with duty allowed to India and Bangladesh

# ix) FTA with TURKEY & THAILAND :

PTA genuine proposal for removal of import duty and to be made at Zero Rated on import of Leather of all sorts i.e. Cow, Buff, Sheep and Goat Skins in the FTA to be executed between Pak-Turkey & Pak-Thailand because the existing Custom Duty in both the destinations are too high will be followed-up again during the next year 2019-20 till its approval vigorously with the aim to enhance the trade between these countries.

# x) <u>2<sup>nd</sup> Phase of Pak-China Free Trade Agreement</u> :

PTA has persistently approached to the Ministry of Commerce for inclusion of Finished / Crust leather of Cow, Buffalo Hides and Sheep & Goat Skins in the list of Item for duty free import into China in the 2<sup>nd</sup> Phase of Pak-China FTA. As intimated by the Ministry of Commerce following HS Codes of Finished Leather has been included for '0' rated import into China as signed by both the countries recently :

PTA will also take-up its proposal for inclusion of remaining HS Codes of Leather i.e. 4107.9100 and 4113.9000 in the  $2^{nd}$  Phase of Pak-China FTA for zero rated import into China.

# xi) <u>Duty Drawback on Finished Leather of Goat/Sheep and Cow/Buffalo.</u>

PTA long pending demand to implement original rates of Duty Drawback on Finished Leather as per recommendation by IOCO and agreed by PTA with effect from the date of the application i.e. May"2012 will again take up with FBR as mentioned in the following Table :

# 2. LEATHER EXPORT PROMOTION COUNCIL (LEPC) :

A Model project for promotion of Leather sector was announced by the Government in the Strategic Trade Policy Framework 2012-15 under the tile "Leather Export **Promotion Council"** (LEPC).

In this regard due to persistent efforts of PTA a "**Memorandum of Understanding**" has been signed between the four Leather Related Association i.e. Pakistan Tanners Association, Pakistan Leather Garments & Manufacturers Association, Pakistan Footwear Manufacturers Association and Pakistan Gloves Manufacturers & Exporters Association with consensus and harmony with the aim to up-grade and promotion Leather Industry of Pakistan.

In this context, PTA has already submitted to Ministry of Commerce CONCEPT PAPER prepared by MOC and PITCO for formation of LEPC.

During the year 2019-20 PTA will again pursue the Government for finalization of the function of LEPC to be functional for the benefits of Leather & Leather Products Exporters.

# 3. <u>REPRESENTATIONS TO GOVERNMENT</u> :

PTA will appoint various Standing Committees for the next year 2019-20 to tackle members' important issues and to move the same through PTA (Central) to the Government authorities concerned for necessary action and redressal on the subject of Sales Tax and their refund claims, Customs, Import/export, Income Tax, Re-finance, Duty Drawback claims of the members etc. and for organizing maximum International Fairs abroad with due subsidy to promote business activities and export.

These activities will keep continue at regular pace using all relevant channels during the next year for redressing the grievances of Association's members concerned through letters, holding meetings with the competent authorities concerned, issuing press statements and holding Press Conferences etc.

# 4. FORMATION OF SYDICATE /LEATHER ADVISORY COMMITTEE :

PTA will take-up its previous demined with the Government for formulation of a **"Syndicate/ Leather Advisory Committee"** comprising representatives of all Government Ministries/Departments concerned specially a representative from Ministry of Commerce, Ministry of Finance, FBR, Ministry of Industries & Production and from Pakistan Tanners Association (PTA) with necessary empowerment to sort out the issues for this vibrant Leather Industry of the country, so that all ongoing issues for the export Industries would be resolved immediately for the desired goals.

# 5. NOMINATION OF PTA'S REPRESENTATIVES IN GOVERNMENT DEPARTMENTS :

### (a) <u>PTA'S REPRESENTATIVE NOMINATED AS MEMBER OF THE BOARD OF DIRECTORS OF</u> <u>TDAP</u>

It is a pride for leather industry that one of PTA senior members Mr. Gulzar Firoz of M/s.Firoz International, Karachi has been inducted as Member of the Board of Directors of TDAP. We now fervently hope that PTA's proposals/key issues related to TDAP would now be taken-up through Mr. Gulzar Firoz smoothly and effectively specifically for releasing of Fairs subsidies expeditiously which are sometimes held up for one reason or the other.

#### (b) INDUCTION OF PTA'S CHAIRMAN ON THE BOARD OF ADMINISTRATORS OF EXPORT <u>DEVELOPMENT FUND (EDF)</u> :

PTA's long pending proposal for induction of the Chairman, Pakistan Tanners Association as Member on the Board of Administrators of EDF is being taken-up with the Ministry of Commerce and will be pursuing constantly till is resolution.

#### 6. ENVIRONMENTAL ISSUES :

PTA will follow-up with the Ministry and Department concerned for maintaining level of NEQS for Leather Industry in Pakistan as it revealed that COD in Pakistan is about 150% as compared to the neighbor countries and requested the Government to implement PTA long pending demand to relax NEQs at least 30% - 40% and provide COD level to the extent applicable to the other Development Countries i.e. 300 mg/l to 600 mg/l.

For the abatement of environmental issues more aggressively to the desired extent, a PTA owned project namely "Combined Effluent Treatment Plant – CETP" located at Korangi Industrial Area (Chamra Mandi) is in operation with satisfaction to cater to the needs of environmental issues with modern sophisticated manner. The plant is really a state of the art at Korangi Industrial area within the section 7-A.

For the up gradation of the Project with most modern machineries & technical abilities, necessary grant has also been approved by EDF Board, which is by virtue of PTA's persistent follow up & demand as now required to the need of the hour for necessary up gradation of the Combined Effluent Treatment Plant for meeting the environmental issues with convenience with latest technology. It is the also the high demand for the enrolment of each Tanneries located at Korangi in Leather Working Group (LWG) to enable our member exporters to export their value added finished leather & allied commodities of Leather Sector of Pakistan to renowned world buyers/customers to meet their essential demand for the enrolment of the Tanneries into the folder of LWG.

To keep awareness amongst our members for the green environment without environmental hazards, a Workshop has been organized by PTA in collaboration with PITCO wherein the foreign experts, **Ms. Jutta Konedler** was invited to educate our members with latest technologies & innovative tools to update the inside system of the Tannery in general and upgradation of Combined Effluent Treatment Plant for meeting the international standards & NEQ's.

The outcome of the workshop organized by PTA in its Southern zone Office, Korangi Industrial Area, Karachi was much productive and enlightened the members for the ongoing features of the CETP & its up gradation process to be completed within coming years at international standard.

# 7. PROJECT FOR IMPROVEMENT OF HIDES & SKINS :

PTA is continuously working on research to reduce economic losses to hides & skins of animals and reduce deceases in livestock in Pakistan specially for the purpose to preserve qurbani hides/skins on the occasion of Eid-ul-Azha as the biggest problem being faced by the tanning and leather industry is poor quality of raw materials receives from slaughter houses and hides markets. Skin diseases, butcher cuts and poor curing caused direct impact on quality of hides and skins which is about 33% loss to Leather Sector.

The major damage to this precious raw material is observed specially on Eid-e-Azha to be commenced in hot weather for which tanners need to work on a project to reduce damage to hides and skins due to late salting, mishandling, and inexperienced and seasonal butchers.

After completion of our Joint Research for which financial assistance was provided by European Union PTA is now working to eradicate these diseases in Punjab.

The Ministry of Livestock Punjab has taken various steps to eradicate Warble Fly Infestation, Ticks and small pox among ruminants in Punjab. During our research an interesting findings was observed after molecular analysis of Cow Hides. The disease commonly identified as small pox was in fact manifestation of ticks inside of hide. PTA's Research Book under Title "Amelioration of economic losses to skins/hides in Ruminants was also published by world renewed Academic Publishers "LAMBERT", UK.

For the next year 2019-20, PTA will suggest to the Department of Livestock to provide "Free Salt Bags" in markets specially created for Qurbani Animals. PTA hope in future years PTA would be able to provide free salt for those buying animals for Qurbani. PTA will also in contact with UVAS for training of butchers to reduce butcher cuts in future.

PTA will request the Secretary Livestock, Punjab to spread awareness through mosques for which Molana to be requested to include this issue in their Khutba during Jumma Prayers for preservation of Raw Hides & Skins on next event of Eid-ul-Azha – 2019 to save the precious raw materials for the country's exchequer.

We are proudly share that a MOU signed among EU Funded-PLCIP, PTA & UVAS during December 2015 for quality improvement of Hides & skins, which was the vital for the Tanning Industry for the curing & smooth & in time procurement of Hides & skins with any sort of decease.

# 8. RESEARCH & DEVELOPMENT (R&D) CENTRE :

PTA will compile global statistical data on export/import of leather and leather products from internet etc. to determine the strategy of various countries and analyze how to compete in the International markets in the wake of international recession and tough competition worldwide with the aim to enhance its scope of activities next year and onward for sustainable development of Leather Industry to provide more detailed data of exports of leather and all leather products based on the figures released by the Pakistan Bureau of Statistics.

# 9. NATIONAL INSTITUTE OF LEATHER TECHNOLOGY (NILT), KARACHI :

NILT is providing technical training and research to students who interested in getting specialization in tanning sector. NILT is catering to the needs of upgrading the leather sector industry particularly through professional skill development of the workforce in the manufacturing units. NILT will upgrade its Laboratory for providing quality research and technical education on historical valued added Leather Industry to students of the institution.



For the up gradation of the NILT (National Institute of Leather Technology) PTA is considering positively to sign MOU with Foreign & local organizations for the upgradation of the Institute to induct more technical & vocational training programme to expand the scope of skill manpower for the Leather Industry of Pakistan particularly for Leather Shoes, Leather Garments, leather Gloves and allied products of the Industry.

In this context, a **Executive Board of NILT** has also been expanded with more induction of members of different fields of Leather Sector of Pakistan so that the proper combination to have representation of all core products/sector of the Industry could be represented in NILT Board for brainstorming and finalization of proposals in future for the betterment of the NILT & Leather Industry of Pakistan.

# 10. PTA'S NEWS LEATHER :

As already planned to improve the working of Pakistan Tanners Association and to make it real service oriented body PTA will continue to publish PTA's Bi-monthly News Leather containing useful relevant information, important and key issues of leather industry, salient features, statistics, outcome of the meetings with the Government Authorities etc. for circulation amongst the Members, Ministries concerned, FBR, TDAP, Government authorities concerned, Foreign Embassies/Consulates in Karachi, Customs, FPCCI etc.

# 11. VIDEO CONFERENCING SYSTEM :

PTA will continue to provide and facilitate its members by organizing Meetings of the Central Executive Committees, AGM and other Standing Committees' meetings as well as balloting of stands of Int'l Fairs through its up-graded Video Conference installed in both PTA Head Office Karachi & branch Office at Lahore.

# 12. DIPLOMATIC ACTIVITIES :

The Diplomatic Affairs Standing Committee of PTA has chalked out programme for the year 2019-22 to arrange meetings with the Consul Generals of Foreign Embassies and other Diplomats in Pakistan in order to invigorate mutual business relations, bilateral trade issues/matters requesting for getting maximum facilities for Visa and market access to the benefit of PTA's members to boost exports. Several such meetings with different Consul Generals etc have already been organized so far which yielded positive results.

However, further plan has been mapped out to invite more foreign diplomats next year also as per their convenience for get together meetings which are considered to be fruitful for our business acumen/promotion of export and to do away tariff and non-tariff barriers.
