The meeting commenced with recitation from the Holy Quran by Mr. Muhammad Musaddiq.

Thereafter, the proceeding on the Agenda of the Meeting started seriatim as under :-

01. TO ELECT OFFICE BEARERS (CHAIRMAN, SENIOR VICE CHAIRMAN AND ONE VICE CHAIRMAN) OF PAKISTAN TANNERS ASSOCIATION (CENTRAL), FOR THE YEAR 2018-2019 TO TAKE THE CHARGE OF THEIR RESPECTIVE OFFICES W.E.F. 01.10.2018 :

The Newly elected Central Executive Committee Members requested Mr. Amanullah Aftab, Outgoing Chairman, PTA (Central) from Karachi and Mr. Mansoor Iqbal, Outgoing, Sr. Vice Chairman, PTA (Central) from Lahore to continue to preside over the meeting till election of the new Chairman, PTA (Central) and conduct the elections of the Office Bearers for the next year commencing from 1st October 2018.

Mr. Muhammad Musaddiq proposed Mr. Agha Saiddain as Chairman, PTA (Central) and Kh.
