The **2<sup>nd</sup> Meeting** of the Central Executive Committee of Pakistan Tanners Association was held on Saturday, the 15<sup>th</sup> December'2018 at 3:00 pm under the Chairmanship **of Mr.Agha Saiddain**, simultaneously in PTA Central Office, Karachi and PTA (Northern Zone Office) Lahore thru video conference

Before taking-up the Agenda, the House was apprised of the sad demises of i) Late mother of Mr. Faisal Junaid and Mr. Fawad Junaid of M/s.Khas (Pvt) Ltd., Karachi ii) Late mother of Mr.Shakil Maqbool Khilji, Director, M/s. Lancer Leather Industries, Sialkot iii) Late Shaikh Rafique Ahmed father of Mr. Nauman Rafique of M/s.Leather Tech, Lahore and brother-in-law of Mr. Mudassar Mehmood of M/s. Mahmood Traders and iv) Late mother of Ms. Tahira Shaheen, Deputy Secretary, PTA (Central). The members present in the meeting offered Fateha praying to rest the departed souls in eternal peace and grant strength to the respective bereaved family members to bear the great loss.

The Committee accordingly adopted the following Condolence Resolution in this regard :-

Thereafter, the proceeding on the Agenda of the Meeting started seriatim as under :-

01. TO CONFIRM THE MINUTES OF THE 5TH & LAST MEETING OF THE CENTRAL EXECUTIVE COMMITTEE OF PTA FY 2017-18 AND 1<sup>ST</sup> MEETING OF THE NEWLY ELECTED CENTRAL EXECUTIVE COMMITTEE FY 2018-19 BOTH HELD ON 29TH SEPTEMBER'2018 AT KARACHI & LAHORE VIA VIDEO CONFERENCE :

Having gone through the Minutes of both the above meetings, the Minutes of the both the meetings were unanimously confirmed/approved by the House, as proposed by Sh. Saqib Saeed Masood and seconded by Mr. Mansoor Iqbal.

The House reviewed the minutes of 5<sup>th</sup> & last meeting of CEC held on 29<sup>th</sup> September'2018 thoroughly and approved unanimously as proposed by Mr. Ejaz Ahmed Sheikh and seconded by Mr. Anjum Zafar.

The Minutes of 1<sup>st</sup> meeting of new CEC for the year 2018-19 reviewed and approved unanimously by the house with satisfaction as proposed by Mr. Agha Saiddain and seconded by Mr. Muhammad Musaddiq

02. TO REVIEW STATUS OF DECISIONS TAKEN DURING  $5^{TH}$  CENTRAL EXECUTIVE COMMITTEE MEETING FY 2017-18 &  $1^{ST}$  CEC MEETING OF PTA FY 2018-19 BOTH HELD ON  $29^{TH}$  SEPTEMBER'2018 :

The implementation to the decisions of both the meetings were reviewed by the house and approved the same with satisfaction.

# 03. TO DISCUSS & CONSIDER FUTURE PROSPECTS FOR NILT WITH THE AFFILIATION OF "AMAN TECH" FOR WHICH A DETAILED PRESENTATION WOULD BE GIVEN BY MR. MUHAMMAD MUSADDIQ TO THE HOUSE FOR FURTHER PROCEEDING:

Before initiating to the remaining Agenda points of the meeting, the matter for NILT with the affiliation of AmanTech was discussed on priority basis, as some of the members who were invited specially for participation were required to depart for their pre-occupation as such the **Chairman, PTA, Mr. Agha Saiddain** requested to Mr. Muhammad Musaddiq to submit the detailed proposal for the NILT with affiliation of Aman Tech, Karachi

Mr. Muhammad Musaddiq, who is the Chairman, BOG of NILT informed the House that the present plight of NILT, Korangi, Karachi specially financial crisis being confronted by the Institute as the approved fund available with TDAP, Karachi to the tune of Rs.39 Million is still pending for the release because of PEMPRA rules resultantly the Institute is in severe financial trouble even not in a position to pay the Salaries to the Staff and accordingly in view of these peculiar nature of circumstances the proposal submitted by AmanTech for necessary collaboration with PTA is found best option for smooth functioning of the NILT with necessary amendments. Mr. Muhammad Musaddiq informed the House that he already made visit to AmanTech Head office alongwith Mr.Rashid Arshad Zahur to discuss all modalities. Mr. S.M. Saleem & Mr. M. Naseem Shafi were of the opinion that PTA may approve the proposal for the affiliation of NILT with Amantech, Karachi in principle while further in deep modalities of the agreement would thoroughly be reviewed & decided by the BOG, NILT, who is the actual authority of the NILT having 26 Board Members after due deliberation in all respect.

In this context, the **Chairman, PTA Mr. Agha Saiddain** also highlighted some certain clauses of the Agreement executed in 1994 between PTA & TDAP (formerly EPB) which are reproduced below for due consideration before proceeding to finalise the proposal of Amantech to avoid any ambiguity & problem in future :-

Clause 7 of the Agreement: Capital cost for the purchase of land and its construction, purchase of machinery and equipment etc. shall be provided by the (Export Promotion Bureau)/TDAP as approved by the Board of Administrators of EXPORT DEVELOPMENT FUND.

**Clause 8 of the Agreement:** That the Association will use the said land/machinery and equipment etc. for the aforesaid purpose and for no other purpose whatsoever.

**Clause 10 of the Agreement**: That if at any time the said land/institute/machinery/equipment is no longer required by the Association for the aforesaid purpose then the Association will forthwith relinquish and restore the same in favour of the (Export Promotion Bureau)/TDAP, Government of Pakistan.

Clause 11 of the Agreement: That if the Association commit a breach of any of the objection contained in the Resolution dated September 01, 1992, Ministry of Commerce, Government of Pakistan, coupled with the Minutes of the Meetings of the Board of Administrators of EDF it shall be lawful for the Ministry of Commerce, Government of Pakistan to enter upon the said land/institute and take physical possession thereof including machinery and equipment etc. and all rights of the Association in the said land/institute/machinery and equipment shall at once cease and determine.

Clause 12 of the Agreement: All disputes and questions in connection with the aforesaid agreement arising between the Association and the Government shall be referred for Arbitration to Vice Chairman, EBP/TDAP whose decision in the matter shall be final and binding.

Mr. Agha Saiddain, Chairman, PTA has categorically emphasized that all above major clauses of the Agreement, which are pivotal should be kept on top priority before finalization the Agreement with Aman Tech, Karachi as the TDAP (Formerly EPB) should be taken on Board in all respect before finalizing, as the supreme authority of NILT as per spirit of the Agreement executed in 1994 between PTA & TDAP (formerly EPB). He also emphasized the need to award some portions/area of the NILT to Aman Tech for their activities and certainly to keep patronage & control of the Institute by PTA/TDAP (formerly EPB) specially Administrative power for the decision of the NILT for any sort of changes/amendments, so that the overall management of the NILT should remain with PTA/TDAP (former EPB). It was also the generated view of the House with the proposal of Mr. Agha Saiddain, Chairman, PTA to keep continue the Leather courses programme in NILT for catering to the needs of the Leather Industry in future with skilled labour as the real essence of the NILT, Karachi as per above clauses of the Agreement. It was also consented in the house to consider to pay the liabilities of NILT in general and to defray the Loans specially for Rs.2 Million payable to PTA either by NILT or Aman Tech, Karachi as was granted to them as Loan.

In this context, Mr. Kamran Habib, Sr. Vice Chairman, PTA offered Southern Zone members services with the induction of some members from Southern Zone in BOG, NILT for their participation for which Mr. M. Saleem Ahmed (Pak Leather) who was invited as special invitee for this specific subject also proposed to consider and replace those members of BOG who are not active in the deliberation/participation in BOG meetings to induct some new interested members of Southern Zone, Karachi in BOG, NILT in place of them, which was approved by the House for the incorporation of new Southern Zone members and accordingly asked Mr. Kamran Habib to submit the names of new interested members from Sothern Zone, Karachi. Therefore, the house approved the proposal of Aman Tech with the above reservations for further proceeding under the patronage of BOG, NILT, Karachi.

#### 04. TO NOTE ACCOUNTS FOR THE MONTHS OF SEPTEMBER, OCTOBER AND NOVEMBER'2018:

Having gone through the accounts, it was proposed by Mr. Hamid Arshad Zahur to consider to invest some portion of amount out of the available fund in PTA Central with certain time period for the maximum interest which could be had by PTA Central, which was appreciated by the House and authorized the Finance Committee of PTA to consider it positively for the proposed investment with the approval of the Chairman, PTA (Central).

A request received from PTA N/Z, Lahore for the allocation of fund of Rs.1.2 million for meeting its recurring expenses was also discussed in detailed by the House, which was also elaborated by Mr. Mansoor Iqbal with previous proceeding made in this regard in earlier CEC Meeting.

Mr. Kamran Habib also shared the statistics of funds already released to both the Zonal offices by PTA Central on account of Pakistan Mega Leather Show, Lahore from 2016 uptill now, besides necessary subsidy @20% (i.e. Rs.2 Million) share which was determined by CEC for the last 4<sup>th</sup> PMLS'2018 out of Rs.20 million would also be disbursed to both the Zonal offices on its receipt from TDAP, Government of Pakistan, for which the Central Secretariat has been directed to further expedite the process for early release of subsidy from TDAP for onward reimbursement among both the Zonal offices for meeting their recurring expenses with facilitation & convenience.

However, in view of scarcity of fund in PTA N/z for meeting its recurring expenses, the house decided to make "Advance Reimbursement" of Rs.1.2 million out of their share of Rs.2 Million (@20% share of 4<sup>th</sup> PMLS'2018 subsidy amount receivable from TDAP), which would be adjusted on receipt of fund from TDAP, Karachi with the motive to facilitate Northern Zone office for meeting their recurring expenses with convenience

The House reviewed the Monthly accounts for the months of September, October and November'2018 minutely and approved the same with satisfaction.

### 05. TO APPROVE VARIOUS CENTRAL STANDING COMMITTEES OF PTA TO BE CONSTITUTED FOR THE YEAR 2018-19

The House reviewed the proposed list of Standing Committee(s) for the year 2018-19 and unanimously approved with the following amendments for incorporation in the respective Standing Committees with the interest of members as shown during the meeting for further proceeding with activation:

To include the following in "Export / Taxes Strategic Standing Committee" which has been renamed and approved by the House:

A proposal floated by Mr. Hamid Zahur that each Standing Committee may submit their progress report to the upcoming CEC Meeting rather than to compile the entire activities of the year in the Annual Report, which was approved by the House.

### 06. TO INFORM THE OUTCOME OF THE MEETING OF PTA DELEGATION HELD WITH THE FEDERAL MINISTER FOR FINANCE ON 30<sup>TH</sup> NOVEMBER'2018 AT ISLAMABAD :

The House was informed that a meeting of PTA delegation was held with Mr. Asad Umer, Federal Finance Minister on 30.11.2018 and a detailed presentation on power point was delivered by Chairman, PTA, Mr. Agha Saiddain to the Federal Finance Minister as highlighted all areas of leather sector of Pakistan specially core issues confronting by the Leather Industry specially in comparison with neighbor competing countries in general and release of pending claims for Sales Tax, Duty Drawback in particular.

A detailed minutes of the meeting has already been circulated vide PTA's letter dated 10<sup>th</sup> December'2018 amongst all members concerned for their review/information, while a copy of the Minutes was also enclosed with the Agenda papers. The Chairman, PTA also highlighted specifically for the inclusion dyed/finished leather in the new DLTL scheme 2018-21, which was eliminated unilaterally.

The Chairman, PTA also appreciated the Karachi members, Mr. Muhammad Shafi, Mr.Ejaz Ahmed Sheikh, Mr. Aziz Ahmed and Mr. Muhammad Imran for arranging this special meeting with the Federal Finance Minister at Islamabad within the shortest time period and accompanied the PTA's delegation and the meeting was really termed most effective to bring our core issues to the limelight. Chairman, PTA also thanked to Khawaja Muhammad Mehr Ali, Vice Chairman, PTA to join the delegation at Islamabad with the Chairman, PTA.

In revert, the Federal Finance Minister heard patiently all grievances of the leather industry presented by the Chairman, PTA thru multimedia power point presentation and he realized the gravity of the situation and assured to remove all bottlenecks of this vital industry of the country specially release of funds on account of Sales Tax, Duty Drawback on priority preferably during next 3<sup>rd</sup> week of December, 2018 to enable the exporters for smooth business activities with convenience. He also consented to have another meeting most probably in Karachi on 22.12.2018 for which a formal request letter has already been sent to him in writing and making persistent follow up with him for confirmation of 2<sup>nd</sup> meeting as proposed by him in Karachi.

## 07. TO DISCUSS DETAILS OF MEETING WITH MR. ABDUL RAZZAK DAWOOD, ADVISOR ON COMMERCE & TEXTILE AND OTHER OFFICIAL OF MOC AT ISLAMABAD ON OCTOBER 02, 2018:

A Meeting of PTA's delegation led by the Chairman, PTA, Mr.Agha Saiddain alongwith Mr. Anjum Zafar and Mr. Mansoor Iqbal was held with Mr. Abdul Razak Dawood, Advisor on Commerce & Textile on 02.10.2018 at Islamabad wherein all core issues of leather sector of Pakistan for which a detailed minutes was already circulated amongst the members concerned a copy thereof was also attached with the agenda papers of the meeting. Mr. M. Younas Dagha Secretary Commerce was also present in the meeting.

Mr.Anjum Zafar informed the House the salient features of the meeting in brief 1) Revision of SRO # 578(I)/2016, which was issued in 2016 but ineffective owing to cumbersome procedure for availing the Govt., incentives, which was well nigh impossible to meet the criteria as revealed drafted defectively as such revision of SRO # 578(I)/2016 with relaxed procedure as already proposed by Mr. Anjum zafar in writing to MOC is necessary to be issued without further delay. 2) Amendments in SRO # 630(I)/2018 for the removal of 2% custom duty on import of wet blue of cow/buffalo as the wet blue for sheep & goat has already been relaxed with the removal of custom duty except cow/buffalo wet blue, besides one commodity of "Cow Split" may also be included in the relaxation of removal of custom duty as proposed by Sh. Saqib Saeed Masood 3) Removal of Quarantine implication imposed vide SRO # 1067(I)/2017 which is obviously unnecessary as the wet blue cow /raw hides &skins are already quarantined at the destination of import 4) Subsidy on individual treatment plants for which approximate figure i.e. Rs.400-500 Million for 10-15 Tanneries (approx) was also given to him for the approval 5) Subsidy on lab testing for leather and most importantly inclusion of dyed/finished leather with H.S. Codes already submitted to MOC in the new DLTL scheme for the year 2018-21.

### **08.** TO DISCUSS ISSUE OF HACKING OF EXPORT DATA OF PAKISTAN BY INDIAN HACKERS TO FACILITATE THEIR EXPORTERS :

Mr. Agha Saiddain, Chairman, PTA informed the House there was an incident was happened that some Indian hackers hacked the export data of Pakistani exporters via very mechanized procedure thru cyber crime, which could be sold out to the Indian exporters on certain payment as it was detected by the Pakistan Government agency and certainly initiating some preventive measures, as some firms concerned shown the stealed data to the house at Northern Zone Office, Lahore and offered educationary session can be made to Southern Zone members Karachi for their education. The house was of the view to be careful for this nefarious activities.

## 09. TO DISCUSS AND CONSIDER EMAIL RECEIVED FROM MR. AMJAD HAFEEZ OF M/S. MUHAMMAD SHAFI TANNERIES (PVT) LTD., KARACHI RECOMMENDING PTA TO BECOME A MEMBER OF INTERNATIONAL COUNCIL OF TANNERS (ICT) :

A proposal received from Mr.Amjad Hafeez was discussed in detail and the Chairman, PTA informed the House member of PTA in International Council of Tanner was discontinued in 2000 at the cost of Rs.50,000/- which was eligible for the member in 2000. In lieu of which it was proposed to consider to enroll PTA with "Leather Naturally" which is also effective under the prevailing circumstances. As such it was decided to get the details for both the organizations with cost for finalization to be made in next CEC Meeting in view of productivity.

### 10. TO INFORM THE UPDATED PROGRESS MADE AS YET FOR ORGANIZING OF 5TH PMLS'2019, LAHORE :

Mr. Muhammad Musaddiq, Convener, PMLS'2019 informed the House regarding update for organizing of the Leather Show specially for the booking of stands and requested to those members who have not yet reserved the booth to make booking of stand for atleast 1 booth to participate as a gesture of cooperation from their side to promote the event. He also informed a request has been made to PM for the inaugural ceremony, but a request was also made to Federal Commerce Minister alternatively for the inaugural ceremony. The house was also informed a request has also been made to Federal Commerce Minister to have a joint meeting at the venue at 12:30 PM with lunch before inauguration to discuss the core issues of leather sector for which PTA is persistently making follow up with them to get confirmation for finalization of the programme.

## 11. TO DISCUSS AND GRANT APPROVAL FOR GETTING NEW WATER CONNECTION IN PTA CENTRAL OFFICE BUILDING AS PER CHALLANS RECEIVED FROM CANTONMENT BOARD, CLIFTON, KARACHI FOR PAYMENT OF NEW WATER CONNECTION FEE TOTALING TO RS.65,156/- :

The House approved the amount of Rs.65,156/- for the water connection for PTA's Central Office Building at DHA, Karachi.

## 12. TO GRANT POST FACTO APPROVAL TO THE NOMINATION OF MR. S.M. MUNEER AS MEMBER FOR THE EXECUTIVE COMMITTEE AND GENERAL BODY OF FPCCI AND MR. GULZAR FIROZ AS MEMBER, GENERAL BODY OF FPCCI FY 2019 :

The House granted approval to the post facto decision for the nominations of 2-PTA members for EC & GB of FPCCI for the year 2019.

### 13. TO DISCUSS PENDING DLTL, SALES TAX AND CUSTOM DUTY CLAIMS:

The House was informed that a meeting was arranged for PTA's Delegation led by Mr. Kamran Habib, Sr. Vice Chairman, PTA alognwith Mr. Amanullah Aftab & Shaikh M. Afzal Hussain with the Head of Department of SBP, Mr. M. Shahid Ashraf on 06.12.2018 at SBP's Office, Karachi and discussed with him all related issues specially release of DLTL claims and in reply thereto he advised to submit the below information:

- 01. Diary # of each claim with amount if pending for the year 2016-17 (as the fund is available with SBP, Karachi and need to identify the case.
- 02. Diary # for the claims 2.5% without incremental effective from July 2017.
- 03. Diary # for the claims 2.5% with incremental exports effective from July 2017

Mr. M. Shahid Ashraf, HOD of SBP also informed that SBP is anxiously looking for the funds receivable from the Ministry of Finance and on its receipt the pending claims would definitely be disbursed amongst the exporters including PTA's members.

### 14. TO DISCUSS OUTCOME OF MEETING WITH SENIOR REPRESENTATIVE MR. YOSHIHSA ONOE OF JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) :

Mr. Agha Saiddain, Chairman, PTA informed the House that a meeting with Japanese Delegation was held recently which was most productive and the head of the Delegation Mr. Yoshisa Onoe of Japan International Cooperation Agency (JICA) has confirmed that 8 members Delegation would be in Lahore on the eve of 5<sup>th</sup> PMLS'2019 Lahore for having detailed interaction for the promotional of bilateral trade relations with PTA's members for which necessary arrangements are being made by PTA for their warm welcome at Lahore with hospitality.

#### 15. ANY OTHER MATTER WITH THE PERMISSION OF THE CHAIR:

1) TO DISCUSS & CONSIDER THE OUTCOME REPORT OF MEETING HELD WITH PRIME MINISTER OF PAKISTAN ON 09.12.2018 IN KARACHI, WHICH WAS ATTENDED BY MR. KAMRAN HABIB, SR. VICE CHAIRMAN, PTA :

A high level meeting was held at Governor House, Karachi on 9<sup>th</sup> December'2018 presided over by the Honourable Prime Minister of Pakistan Mr. Imran Ahmed Khan Niazi, which was also attended by Mr. Kamran Habib, Sr. Vice Chairman, PTA and he highlighted vital issues of the leather industry specially inclusion of dyed/finished leather in the new DLTL scheme for the year 2018-21 and emphasized the need again to form an "Advisory Committee" as discussed with the Federal Finance Minister to have representation of allied Ministries, Government Departments, FBR and representative of PTA to become effective platform for the resolution of ongoing problems and future planning for the promotion of country's exports. The proposal was really appreciated by the PM and assured to revert back to PTA in this regard to make effective proposal for the Advisory Committee.
